- (d) what percentage of criminal cases brought before the courts resulted in a suspended custodial sentence in each of 2008, 2009, 2010, 2011, 2012, 2013 and 2014; and
- (e) what percentage of criminal cases brought before the courts failed in a successful conviction due to insufficient evidence in each of 2008, 2009, 2010, 2011, 2012, 2013 and 2014?

# 2125. Ms M.M. Quirk to the Parliamentary Secretary representing the Minister for Child Protection:

I refer to the Department of Child Protection's three strikes policy for anti-social behaviour, and ask:

- (a) can the Minister advise whether advice is given to the Department if eviction is contemplated and children reside at the premises; and
- (b) if yes, at what stage does that occur?

# 2126. Ms M.M. Quirk to the Minister for Housing:

I refer to the Department of Housing's policy to evict after three strikes for anti-social behaviour, and I ask:

- (a) does the Department of Housing notify the Department of Child Protection where children reside at the premises;
- (b) if yes, at what stage does that notification occur; and
- (c) if yes, upon receipt of such advice what action does the Department of Child Protection take?

# 2127. Ms S.F. McGurk to the Minister for Transport:

- (1) Are there plans to build a sub-station capacity on the Fremantle rail line so that scheduled or unscheduled interruptions which occur on part of the line does not result in whole line closures?
- (2) Is there a budget allocation for that work, and what is it?
- (3) If the work is planned, when is it scheduled to commence?
