WEDNESDAY, 28 JUNE 2017

1. Meeting of Council

The Council assembled at 1.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair and read prayers.

2. Climate Change and Measures for Amelioration

Motion No. 1 having been called, debate resumed on the motion of Hon Robin Chapple as follows —

That the House note the impact of climate change and give consideration to measures that may be introduced to ameliorate its damaging and long term effects on Western Australia's social, economic and environmental prosperity.

Question — put and passed.

Motion agreed to.

3. Western Australia's Finances

Motion No. 2 having been called, the Leader of the House on behalf of Hon Sally Talbot, pursuant to notice, moved —

That this House condemns the former Liberal-National Government for its reckless mismanagement of the State's finances.

4. Sentence Administration Amendment Bill 2017

The Acting President reported the receipt of Message No. 12 from the Legislative Assembly forwarding the Bill for concurrence.

The Leader of the House representing the Attorney General moved, That the Bill be read a first time.

Question — put and passed.

Bill read a first time.

The Leader of the House representing the Attorney General moved, That the Bill be read a second time.

The Leader of the House representing the Attorney General tabled an Explanatory Memorandum relating to the Bill. (Tabled Paper 318).
