- a) to identify the current areas of tension between the Western Australia Police and the Corruption and Crime Commission which impact on their operational effectiveness; and
- b) to identify best practices in police oversight based on those that combine independence for policing operational functions and appropriate accountability, transparency and oversight of their operations.
