10. Opposing the Marriage Equality Plebiscite

Non-Government Business No. 1 having been called, Hon Sally Talbot moved, without notice —

That the Legislative Council supports the Premier of Western Australia in his call for the marriage equality plebiscite to be scrapped and for changes to the Marriage Act to legislate for marriage equality to be decided by a vote in the Federal Parliament.

Debate ensued.

11. Supporting Marriage Equality Plebiscite

Private Members' Business No. 1 having been called, Hon Nick Goiran moved, without notice — That this House —

- (a) acknowledges the undertaking given by the Turnbull Coalition Government that if re-elected it would instigate a plebiscite on the definition of marriage;
- (b) notes the overwhelming vote of Western Australians for the Turnbull Coalition at the 2016 Federal election;
- (c) commends the Turnbull Coalition for its public statements since its re-election recommitting to fulfil its undertaking; and
- (d) calls on the Parliament of the Commonwealth of Australia to facilitate the fulfilment of the undertaking by giving to the people of this State a say on the definition of marriage and approve a plebiscite.

Debate ensued.

Hon Nick Goiran, by leave, tabled a *Hansard* transcript from the House of Representatives on 15 September 2015 and a transcript of an interview given by the Prime Minister, Hon Malcolm Turnbull, on the 7.30 program on the Australian Broadcasting Corporation on 18 July 2016 in relation to the marriage equality plebiscite. (Tabled Paper 4435).

Debate resumed.

Motion lapsed.

and for related purposes." be introduced and read a first time.
