- (b) has the Minister read the 2011–2012 Synergy Annual Report which was tabled in the Legislative Assembly on 20 September 2012;
- (c) is the Minister aware that this report includes a *Statement of Comprehensive Income* For the Year Ended 30 June 2012;
- (d) is the Minister aware that this statement notes that *Profit Before Income Tax Equivalent Expense* was \$120,969,000;

- (e) is the Minister aware that this report also includes a *Statement of Financial Position* as at 30 June 2012;
- (f) is the Minister aware that this Statement reports that Synergy's net assets were \$359,378,000; and
- (g) is the Minister aware of these matters, does he still maintain that Synergy has a profit of \$14 million and sales of \$2 billion, but no assets, and if not, when will he be correct the record of the Parliament?

249. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's comments in the House on 17 April 2013 in relation to the South West Interconnected System stating that there is a large number of stranded assets, and I ask, please list the specific stranded assets to which he referred?

250. Mr W.J. Johnston to the Minister for Energy:

I refer to the media release issued by the Hon Peter Collier on 30 November 2011 entitled *Domestic Gas Secured Through Gorgon Contract*, and I ask:

- (a) is the Minister aware that this media release noted the signing of gas supply contracts by Verve and Synergy with the Gorgon Joint Venture;
- (b) is it true that the singing of these agreements provides long term and reliable domestic energy supply, which will enable us to maintain a strong and vibrant economy in conjunction with an additional stream of energy security; and
- (c) is it true that singing of these agreements provide supply tenure that will deliver energy security for decades?

 - (c) how many Department of Housing houses have been transferred to the community sector?

 - (iii) will this proposed power station add to what the Minister states is a 700 megawatt overcapacity in the South West Interconnected System; and
