Deputy Chair's Ruling

The Deputy Chair ruled as follows —

Members, Hon Kate Doust has moved to insert a new clause 5A. I have had the opportunity to consider and receive advice on this matter. Members, in my view the proposed amendment by the Deputy Leader of the Opposition, Hon Kate Doust, goes outside the scope of the Bill. The primary restriction on a Committee of the Whole House imposed by Standing Order 134(1)(a) is that any amendment that it makes must be relevant to the subject matter of the Bill. The subject matter of the Bill is the provisions of the Bill as printed, read a second time, and committed to the Committee of the Whole House.

It is not sufficient that an amendment fall within the title of the Bill which, in many cases, simply recites that the Bill is one to amend a particular Act—in this case, the *Electoral Act 1907* or the *Freedom of Information Act 1992*. The amendment proposes to change a section of the parent Act not dealt with in the amendment Bill, and that is section 16E. This section determines when a distribution effectively commences. The amendment Bill primarily deals with the period over which the distribution process is to occur, extending that period by one month from seven months to eight months and incidental matters. There is no amendment in the Bill dealing with when a distribution is to commence. Accordingly, I rule the amendment out of order.

Clause 6 agreed to.

Clause 7.

Debate ensued.
