### 1. Meeting of Council

The Council assembled at 2.00pm pursuant to Temporary Orders.

The President, Hon Barry House, took the Chair and read prayers.

#### 2. Statement by President — Legislative Council Chamber — Audio System

The President made the following Statement —

I advise that the Chamber audio system is currently experiencing difficulties and the microphones located in front of Members are not recording or broadcasting speeches. Technicians are currently investigating the problem and hope to have the audio system restored shortly.
