#### 2. Petitions

Wandina Primary School – Mr I.C. Blayney presented a petition from 33 persons requesting that the Legislative Assembly calls on the Minister for Education to include the Stage 2 build for Wandina Primary School in the next State Budget (P. 226).

North West Coastal Highway – Mr I.C. Blayney presented a petition from 309 persons requesting that the Legislative Assembly asks the Minister for Transport to implement the best solution to improve road safety at the North West Coastal Highway and Hosken Street intersection at Bluff Point (P. 227).

Liquor Licence – Mr C.D. Hatton presented a petition from 375 persons requesting that the Legislative Assembly resolves that a liquor licence is not granted for the planned Liquor Land development in Northlands Shopping Centre (P. 228).

School Buses in Dunsborough – Ms L. Mettam presented a petition from 207 persons asking the Legislative Assembly to request that the Government provides more school buses for Dunsborough and that all buses have seat belts (P. 229).

### 17. Remote Aboriginal Communities

Mr B.S. Wyatt, pursuant to notice, moved,

That the House condemns the Premier for the ongoing uncertainty, confusion and fear that he has created in remote Aboriginal communities since stating that he would close 150 remote communities and calls on the Premier to immediately:

- (a) seek to have the Commonwealth Government reverse or delay its decision to cease funding remote Aboriginal communities;
- (b) clarify on what basis the Government will base its decision on which communities are worthy of future Government investment;
- outline the base line data that the Government has collected to justify the Premier's statement that remote communities have failed; and

(d) outline the Government support that will be provided to those people currently living on remote communities to ensure that their closure will result in better social outcomes.

Debate ensued.

Debate interrupted by the Chair (Premier speaking) and adjourned until a later stage of the sitting.
