## **THURSDAY, 19 MAY 2016**

## 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Barry House, took the Chair and read prayers.

#### 2. Petition

Hon Lynn MacLaren presented a petition from 163 petitioners requesting the Legislative Council to support the establishment of a Royal Commission into the use of pesticides and harm to public health. (Tabled Paper 4133).

## 3. Ministerial Statement — Aboriginal Affairs Planning Authority

The Minister for Aboriginal Affairs made a Ministerial Statement with respect to the tabling of a report that outlines a proposal to amend the boundaries of Aboriginal Reserves 1834, 20927 and 22615 to allow for the dedication of the Broome to Cape Leveque Road located on the Dampier Peninsula.

The Minister for Aboriginal Affairs tabled a report entitled, *De-proclamation of Aboriginal Reserves on the Dampier Peninsula*. (Tabled Paper 4134).

Hon Ken Travers sought leave to continue his remarks at a later stage of this day's sitting. Leave granted.

Debate adjourned pursuant to order.

Hon Ken Travers presented Report No. 63 of the Standing Committee on Estimates and Financial Operations, *Budget Estimates Hearings* 2015–16. (Tabled Paper 4136).

Hon Rick Mazza presented the Report of the Select Committee into the Operations of the Royal Society for the Prevention of Cruelty to Animals Western Australia (Inc). (Tabled Paper 4137).

### 9. **2016–2017 Federal Budget**

Non-Government Business No. 1 having been called, Hon Samantha Rowe moved, without notice — That this House notes the adverse effects imposed on Western Australia by the Federal Liberal-National Government's 2016–17 Budget.

Debate ensued.

Motion lapsed.

The Order of the Day having been called, Hon Robin Chapple moved, without notice —

Question — put and passed.

Debate resumed.

Hon Lynn MacLaren, by leave, tabled documents in relation to the *Harm Reduction Innovation Fund Reducing Harm, Saving Lives.* (Tabled paper 4138).

Debate resumed.

On the motion of Hon Samantha Rowe the debate was adjourned to the next sitting.

The Minister for Planning on behalf of the Minister for Housing tabled documents in relation to residential dwellings added to the Department of Housing stock in 2015 in the South West, in response to question on notice No. 3990 asked by Hon Adele Farina. (Tabled Paper 4143).

The Parliamentary Secretary to the Minister for Agriculture and Food on behalf of the Parliamentary Secretary to the Minister for Tourism tabled documents in relation to membership and sponsorship details, in response to question on notice No. 3949 asked by Hon Kate Doust. (Tabled Paper 4144).

### 15. Statement by President — Legislative Assembly Estimates Hearings

The President made the following Statement —

Members, when the House rises this evening, I ask that you take a moment to clear your desks of personal and work material prior to leaving Parliament as this Chamber will be occupied by the Legislative Assembly next week for its Budget Estimates hearings. Any items remaining on desks tonight will be cleared by staff and retained until the next sitting week.

## 16. Select Committee into the Operations of the Royal Society for the Prevention of Cruelty to Animals Western Australia (Inc)

Hon Ken Travers raised the following Point of Order —

Mr President, I have a point of order and I seek your clarification and guidance on the actions that the House can take. This morning we received the report of the *Select Committee into the Operations of the Royal Society for the Prevention of Cruelty to Animals Western Australia (Inc)*. The Select Committee had a very narrow set of terms of reference, which read —

- ... a Select Committee be established to inquire into the operations of The Royal Society for the Prevention of Cruelty to Animals Western Australia (Inc), including an examination of —
- (a) its funding from the Government;
- (b) its objectives; and
- (c) the use of its powers.

It is worth noting at this point that those terms of reference did not include any reference to "any other relevant matters", which is included from time to time in terms of reference. *Erskine May's Parliamentary Practice* states that the interpretation of the terms of reference for a committee is a matter for the committee. However, the issue I raise tonight with you, Mr President, is that during the debate to establish that committee, the House considered an amendment moved by Hon Lynn MacLaren —

... the Select Committee also inquire into the use of the powers of the Department of Agriculture and Food Western Australia and, in particular, its administration of the *Animal Welfare Act 2002*.

During the debate on that amendment, a number of Members, including Hon Sue Ellery and Hon Ken Baston, made it clear that in their view they did not want to see those matters investigated by the committee. In fact, Hon Ken Baston said —

It is no surprise that we will not be supporting this motion. We are already doing a review, which I announced and which Hon Sue Ellery just alluded to. I wanted to correct one thing ...

He finishes his statements with —

We already have an inquiry; we do not need another motion.

On reading the Select Committee's report today, the committee has clearly gone into a range of matters relating to the *Animal Welfare Act* and its administration by the Department of Agriculture and Food, which was directly contrary to a decision of the House.

Mr President, I also draw to your attention a letter that I found on the Select Committee's website. It was written to the Select Committee by the Department of Agriculture and Food's Acting Director, Legal and Commercial, Felicity Heffernan. The letter states —

I would like to draw to the Select Committee's attention to a number of matters in some evidence and submissions that have been provided under the Parliamentary Privilege that do not relate to the specific terms of reference of the Inquiry.

It concludes —

I am instructed that DAFWA does not support inaccurate evidence and submissions about staff which are outside the terms of reference of your inquiry.

That letter is dated 4 April.

Although I accept that the interpretation of the terms of reference is a matter for the Select Committee in accordance with *Erskine May*, I still argue that it is important that committees stick to the broad terms of reference provided by this House, particularly when this House has taken a decision to limit the terms of reference. Mr President, I seek your ruling and guidance about the status of the recommendations and the elements of the report that are clearly outside the terms of reference and directly contrary to a decision of this House.

President's Ruling

The President ruled as follows —

I note the terms of reference of the committee, and I will read them again for the benefit of Members. On Wednesday, 13 May 2015, the Legislative Council ordered that a select committee be established to inquire into the operations of the Western Australian Royal Society for the Prevention of Cruelty to Animals. The terms of reference for the inquiry state that —

The Select Committee be established to inquire into the operations of the Western Australian Royal Society for the Prevention of Cruelty to Animals, including an examination of:

(a) its funding from the Government;

- (b) its objectives; and
- (c) the use of its powers.

The key word is "including". Therefore, in relation to the terms of reference, I do not believe that Hon Ken Travers has a point of order. Hon Ken Travers' comments, I think, would be perfectly appropriate during the debate on consideration of committee reports when it comes up at some later stage of the sitting of this House. It was really more a Member's Statement than a point of order.

Hon Sue Ellery raised the following Point of Order -

Mr President, on the same point of order, if I may, I wonder if I might ask you to give consideration to providing some guidance to the House at least. When the House has made an explicit decision not to include a particular matter in the terms of reference for an inquiry, and it appears that the committee has examined matters that fit within the explicit decision of the House not to examine those matters, where does that leave us? If the House has expressed a point of view that it does not want the committee to look into X, and the committee report clearly has findings and recommendations about X, where does that leave that initial decision of the House? I would ask you to consider that, Mr President.

### President's Ruling

The President ruled as follows —

I will take that on board, and if there is anything further to add to what I said previously, I will come back to the House and inform the House.

Hon Ken Travers raised the following Point of Order —

Mr President, also in considering the matter further, I think the key statement is that the Select Committee was established to inquire into the Royal Society for the Prevention of Cruelty to Animals WA, including an examination of the use of its powers. As Hon Sue Ellery said in the debate when we defeated the motion to extend the powers of this committee, the powers in that regard were the powers of the RSPCA under its constitution, not the powers under the Animal Welfare Act. The substantive issue is an inquiry into the RSPCA.

#### President's Ruling

The President ruled as follows —

I believe that is a point of view rather than a point of order. Nevertheless, I will consider all those matters and add anything that is necessary when I report to the House at some later stage.

#### 17. **Health Services Bill 2016**

Debate resumed on the second reading of this Bill (see item 13 above).

Question — put.

The Council divided.
