1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Barry House, took the Chair and read prayers.

2. Petition

Hon Stephen Dawson presented a petition from 3 petitioners requesting the Legislative Council to amend the *Mental Health Bill 2013* to provide for the recording of diagnostic interviews that result in involuntary treatment of patients. (Tabled Paper 1565).

Non-Government Business No. 1 having been called, Hon Sue Ellery moved, without notice —

That this House condemns the Liberal-National Government for its attack on seniors' cost of living by —

- (a) imposing severe rises in fees and charges; and
- (b) failing to stand up to the Federal Government's funding cuts to seniors.

9. Forest Management Practices — Prescribed Burning Programs

Private Members' Business No. 1 having been called, Hon Nigel Hallett moved, without notice — That the Council —

- (a) recognises that Western Australia's declining prescribed burning programs and forest management practices are seriously impacting on the security and safety of Western Australian residents and the environment; and
- (b) calls on the State Government to urgently re-examine the process by which prescribed burning programs are implemented to
 - (i) provide broad scale fuel reduction to increase bush fire suppression potential and reduce bushfire size;
 - (ii) increase catchment water yield and daily run off; and
 - (iii) provide a safe environment and help maintain biodiversity and enhance ecological processes on which native plants and animals depend.

Debate ensued. *Motion lapsed.*

- (1) This section applies to the
 - (a) NDIS Rules (Commonwealth);
 - (b) changes to the NDIS Rules (Commonwealth);
 - (c) NDIS Act (Commonwealth);
 - (d) Australian Standards and Codes.
- (2) Where any document to which this section applies is made publicly available in accordance with section 57A, the Director General must, within 10 business days after the day on which the document is first made publicly available, cause to be published in the *Gazette* notice of
 - (a) the making of the document; and
 - (b) where the document is publicly available.
- (3) If notification of the making of a document to which this section applies is not published in the *Gazette* in accordance with subsection (2), the document ceases to have effect on the expiry of the 10th business day after the day on which the document was first made publicly available, but without affecting the validity or anything done, or of the omission of anything in the meantime.

- (4) A copy of the document to which this section applies must be laid before each House of Parliament within 6 sitting days following notification of the making of the document in the *Gazette* in accordance with subsection (2).
- (5) If notification of the making of a document to which this section applies is published in the Gazette, the *Interpretation Act 1984*, section 42 applies as if the document were a regulation published in the Gazette.

The Parliamentary Secretary representing the Minister for Regional Development tabled a document in relation to Royalties for Regions stakeholder functions, in response to a question without notice asked by Hon Robin Chapple. (Tabled Paper 1573).

15. Statement by President — Committee of the Whole — Minister's Seating

The President made the following Statement —

Yesterday the issue came up about the Minister for Mental Health preferring to sit in the chair furthest away from the Chair and Hansard, after being invited by the Chair to take the seat closest to her. I was approached by several Members with questions about the practice involved and whether the Minister had disobeyed the Chair. I have investigated this matter today and spoken with the Minister for Mental Health and the Clerk. The Minister for Mental Health indicated that she had always taken this seat when handling Bills in committee and preferred this seat as it gave her better vision of her advisers, the opposition benches where most questions come from, the Chair of the Committee, and her leader, if necessary. I have also checked with Hansard whether there are any issues regarding where the Minister sits. Hansard reporters have no difficulty with a Minister or a Parliamentary Secretary who is handling legislation sitting at either seat. Their only concerns arise when the Minister or Parliamentary Secretary, or any Member for that matter, turns their back on them so it is harder to pick up comments. If anything, they prefer the position adopted by the Minister for Mental Health at the table as it is more face on to Hansard's position. There is no firm Standing Order, convention or practice on this matter, so I believe it is open to the Minister or Parliamentary Secretary handling legislation during the Committee of the Whole to choose whichever chair they prefer at the table. The important matter relates to how they make their remarks so that all Members can hear them clearly and *Hansard* can record them properly.
