1. Meeting of Assembly

The Assembly met at 12.00 p.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Speaker's Statement - Respect for the Chair

The Speaker advised members that there was an increasing tendency for members to move around the Chamber and speak when the member presiding was on his or her feet. The Speaker noted that Standing Order 84 provides that when the Speaker stands, members will sit down and be silent, and that when the Speaker is putting a question, members will not move around the Chamber.

3. Petitions

Liquor Stores - Mr J.N. Hyde presented a petition from 11,423 persons requesting that the Government allow liquor stores to trade seven days a week (P. 149).

Liquor Stores - Mr B.S. Wyatt presented a petition from 535 persons supporting reforms to the *Liquor Licensing Act* (P. 150).

Mueller Park, Subiaco - Ms S.E. Walker presented a petition from 85 persons requesting that opposition to the destruction of Mueller Park, Subiaco be noted (P. 151).

The *Police (Compensation for Injured Officers) Amendment Bill 2006* required a message but one had not been received. Therefore, in accordance with the practice of the House, the question for the second reading would not be finally put to the House until a message is received.

The Acting Speaker directed that the Bill be placed at the bottom of the Notice Paper until a message is received.
