# 1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The Clerk, Mr Nigel Pratt, took the Chair.

#### 2. Election of the President

The Clerk announced that in accordance with the provisions of the *Constitution Acts Amendment Act 1899* the Office of the President was vacant, whereupon the Leader of the House, addressing the Clerk, moved, without notice —

That Hon Kate Doust do take the Chair in the Council as President.

Hon Peter Collier seconded the motion.

No other Member being proposed and Hon Kate Doust having accepted the nomination, Hon Kate Doust was conducted to the Chair by her proposer and seconder and having made acknowledgement, received the congratulations of the Council.

The President made the following Statement —

I would like firstly to acknowledge the traditional owners of the land upon which we meet. I thank all Members in the Chamber for putting their faith and trust in me to take on this role, and I commit to conducting myself in a fair and impartial way by way of engagement with each and every one of you over the next four years. I acknowledge the significance of being elected as the first female President of this Parliament. This is our fortieth Parliament, so it has taken us a while to get there, but I think it certainly opens up the doors to demonstrate that women have the opportunity to participate in this place at all levels. I also acknowledge the Leader of the House in her role, which is also a significant change for this place. I acknowledge my predecessor, Hon Barry House, who operated this place in an exemplary manner; he is a particularly fine role model. He certainly conducted himself in an impartial way and I hope that over the next few years we are able to continue some of the work that he put in place, making sure that this very important place in our democracy is able to continue and be sustainable. Given my own experience as a working mother, I am very keen to make sure that we look at ways to make Parliament much more family friendly. I am also very keen, given my passion for all things tech, to investigate ways in which we can incorporate technology into this place in a range of areas, to not only make us more productive, but also open up opportunities for better engagement with our community. I am very excited about this opportunity and I look forward to working with Members in this place and the very excellent staff we have in this Chamber. I wish all Members well for the fortieth Parliament.

### 13. National Disability Insurance Scheme

Hon Alison Xamon: To move on the next day of sitting —

That this House notes the significant impacts on people with disability and their families of ongoing uncertainty about which form of National Disability Insurance Scheme will be adopted in Western Australia.

Whether the Government decides to adopt the National Disability Insurance Scheme or the National Disability Insurance Scheme *My Way* model, it is imperative that those whose lives will be most affected by the decision are kept informed in an ongoing and meaningful way.

Furthermore, it is essential that a co-design model for engagement that involves people with disability and their families in the design of governance, policy and operational aspects is developed to inform the delivery of whichever scheme is agreed to.

Noting the significant uncertainty in the funding of disability services in Western Australia, this House calls upon the Government to ensure that there are mechanisms in place to ensure —

- (a) people with disability and their representative organisations are included in governance structures and inform service delivery design; and
- (b) that the decision making process is fully transparent.

#### 14. Metronet

Hon Alanna Clohesy: To move on the next day of sitting —

That this House congratulates the McGowan Government on its Metronet policy and notes the benefits Western Australia will derive, including the jobs to be created, from this transport and planning initiative.

# 15. Building and Construction Industry Training Fund

- (c) supports the amendment of regulation 3AA of the *Building and Construction Industry Training Fund and Levy Collection Regulations 1991* therefore requiring construction projects in the mining and petroleum industry to contribute to the training and skills development in the building and construction industry; and
- (d) calls on the Government to immediately amend the regulation to support local job creation and skills development across the building and construction industry.
