**C2:** Can the Minister provide a list of agencies that are captured under the block funding scheme, what they were funded previously and what their 50 per cent will be in 2016-17.

#### **Answer**

Organisations in receipt of block funding from the Disability Services Commission are identified in the table. They provide a range of services including disability professional services, aids and equipment, continence products, family support and recreation services. The organisations that provide recreation services are identified with an asterisk (\*). For many of these providers recreation forms only one component of their block funded services.

Fifty per cent of recreation services funding has been individualised. These funds have been allocated as individual funding packages to people who have been in receipt of recreation services as identified by the organisation from which they have received this service.

Activ Foundation Inc. and The Cerebral Palsy Association of Western Australia Ltd are adopting innovative service models and have voluntarily relinquished 50 per cent of recreation funding, while guaranteeing that no one would be disadvantaged.

The remaining organisations will receive fifty percent of the 2015-16 level of funding in 2016-17 and the remaining fifty percent will be received as individual funding. It is the way in which the funds are allocated that has changed.

## Hon Lynn MacLaren asked:

**C3:** Can the Minister provide the details of the grants scheme. Specifically, what grants are provided and how does one apply for them as well as a list of the names of the five organisations that are in the space of providing service agreements.

#### **Answer**

In 2016-17, the Ethnic Disability Advocacy Centre, Explorability (incubated by Headwest Brain Injury Association of WA Inc.) and People with Disabilities (WA) Inc. (working in partnership with Advocacy South West Inc.) will respectively receive \$580,000; \$500,000; and \$720,000 per annum to provide advocacy services for people with disability.

In addition, the Disability Services Commission will provide grants to relevant organisations to undertake targeted systemic advocacy initiatives that are developed with defined outcomes. An initial allocation of \$600,000 has been made for this purpose in 2016-17.

Over the course of the year the Commission will target specific areas requiring systemic advocacy, primarily related to the key objectives in the National Disability Strategy, and will use State Government procurement processes to allocate grants to organisations with the skills and capacities to undertake the systemic advocacy roles.

# Hon Alanna Clohesy asked:

**C4:** Can the Minister provide a breakdown of the \$7.2million in savings that the Commission has made in the 2016-16 financial year through the transition to privatisation of accommodation service.

#### Answer

Of the \$7.2 million the Disability Services Commission returned to the Consolidated Account in 2015-16:

- \$4.2 million is the net estimated savings arising due to the transition of some accommodation services to alternative, non-government providers;
- \$2 million was generated through payments returned from service recipients who have settled compensation claims; and
- \$1 million was realised through a reduction in Workers Compensation premiums as a result of good performance in Occupational Safety and Health and injury claims management.

# Hon Stephen Dawson asked:

**C6:** Can the Minister provide details as to whether somebody has been transferred to a non-government organisation, come back to DSC and does not look like going back to their new accommodation service.

## **Answer**

I have been advised by the Disability Services Commission that all individuals who transferred to another service provider through the transition process remain with their chosen service provider; no individual has returned to the Commission's accommodation service.

## Hon Stephen Dawson asked:

**C7:** Can the Minister provide the number of adverse incident reports that have been lodged by non-government organisations following the transition to private providers.

## **Answer**

Mandatory reporting of serious incidents is required by all disability service providers under the Disability Services Act 1993, and the service provider's service agreement with the Disability Services Commission.

A serious incident could encompass a variety of everyday life events, or other situations including serious illness, known behaviours of concern, unintentional self-injury and welfare related concerns.

21 serious incident reports have been lodged in relation to individuals who have transitioned from the Disability Services Commission to the non-government sector, since the first facility transitioned in December 2014. A total of 140 individuals have transitioned
