- 1. Page 51 refers to the total number of employees and FTE:
 - (a) Please provide the total number of employees (and FTE equivalent) working in regional Western Australia and a region-by-region breakdown of employee locations as at 30 June 2017.
 - (b) Please provide the total number of employees (and FTE equivalent) working in regional Western Australia and a region-by-region breakdown of employee locations as at December 2017.
 - (c) Please provide a region-by region breakdown of the total number of positions required to be cut by Water Corporation as part of the State Government's Voluntary Targeted Separation Scheme.

Answer:

1(a)-(b) The Water Corporation has five operational regions across Western Australia. Operational and seasonal demands require some employee movements across regions and between metropolitan and regional locations.

- 4. Page 31 refers to the Farmlands Project:
 - (a) As of December 2017, how many local and non-local contractors have been used to date?
 - (b) As of December 2017, how many of these contractors were/are local Aboriginal businesses?
 - (c) As of December 2017, how many training places have been created?
 - (d) What steps are in place to increase the participation of local contractors, particular Aboriginal businesses?

Answer:

- 4(a) Seven locally based contractors have been awarded a total of 24 contracts. One non-local contractor was used.
- (b) One Aboriginal business has completed three separate contracts.
- (c) None.
- (d) The Water Corporation conducted an extensive engagement process at the commencement of the project with local shires, business groups and communities, including presentations in several of the towns, field days and Development Commission meetings. This engagement led to great interest in the work from local, regional and Aboriginal businesses that subsequently resulted in successful bid awards to these companies.

The Water Corporation continues to actively seek out and encourage local, regional and Aboriginal businesses to bid. The program is structured so that the jobs are sized and grouped for delivery by local contractors. The bid evaluation criteria also supports the selection of competitive local, regional and Aboriginal contractors.

In October 2017, the Water Corporation held its first Aboriginal Supplier Tradeshow that was attended by 30 wholly owned and operated Aboriginal businesses from all over Western Australia, with other companies and government agencies also attending.

The Aboriginal suppliers that took part in the tradeshow came from a range of industries including civil construction, electrical, plumbing, water/wastewater services, employment services, office stationery supplies and landscape gardening.

The Water Corporation is committed to fostering partnerships with Aboriginal suppliers across the State as a key part of its Reconciliation Action Plan, which assists in the ongoing growth of Aboriginal economic development and jobs.
