

# Full Terms and Conditions of Use

By using this Standards On-Line service, you the **Licensee**, are agreeing to the terms and conditions of this contract.

The **Service** is the provision of online, web-based access to a **Licensee**-nominated collection of current **Publications** in electronic format.

**Commencement Date** means the date that the **Service** is initially provided to the **Licensee**, as set out in section 4.

**Initial Term** is the initial 12 months of the agreement from the **Commencement Date**.

**Intellectual Property** means all current and future registered and unregistered rights, including copyright and trademarks, in respect of the **Service**.

**Internal Use** means use of the **Service** within the **Licensee** that is the company or other legal entity identified by, for example in Australia, the Australian Business Number (ABN) provided.

**Licensee** means the purchaser and user of the **Service**.

**Licensor** means the supplier of the **Service**.

**Reference Collection** means a hard copy collection comprising more than 10% of the number of **Publications** within the **Service** subscribed to by the **Licensee**.

**Service** means the provision, on the payment of an initial subscription, of online access to a **Licensee**-nominated selection of **Publications** in electronic format. The **Service** also provides access to a bibliographic database of **Publications**, and the **Licensee** has the option to add **Publications** to the **Service** at any time during the **Subscription Period** at an additional fee per added **Publication**, payable at the time the **Publication** is added.

**Subscription** means a fixed term access (normally 12 months) to the **Service**, renewable by the **Licensee** on the terms of this agreement on each anniversary of the **Commencement Date**.

**Subscription Period** means the period for which the **Licensee** has paid the relevant **Subscription** fee on the terms of this agreement

## 2. Service terms and conditions

The **Licensee** is granted a non-exclusive and non-transferable licence to use the **Service** during the **Subscription Period** on the terms and conditions of this agreement.

The **Licensor** does not transfer any rights in the **Service** or **Intellectual Property**, but grants to the **Licensee** a licence to use the **Service** on the terms of this agreement. It is expressly agreed that the **Licensor** retains all title and rights of ownership, including copyright or other intellectual property rights, or distribution rights to the **Service** and **Intellectual Property** and the **Licensee** is provided with the **Service** subject to those rights.

The **Licensee** does not own the electronic downloaded files, printed files, any disks, documentation or manuals on which the **Service** or **Intellectual Property** is originally or subsequently recorded or fixed.

In consideration for entering into this agreement and agreeing to pay the **Subscription** fees to the **Licensor**, the **Licensee** may use the electronic or printed files to obtain information contained in them for its **Internal Use** on the terms of this agreement.

The **Licensee** may:

The **Licensee** must not:

2. challenge or call into question the **Licensor's** ownership of **Intellectual Property** rights in respect of the **Service**;
3. transfer an electronic file or printed **Publication** to any party other than an employee of the **Licensee** without the prior written consent of the **Licensor**;

#### 4. Term and termination or suspension of the Service

Printed or downloaded electronic copies of any part of the **Service** must be removed or destroyed on non-renewal of the **Service** subscription or termination of this agreement. At its discretion, the **Licensor** may require the **Licensee** at its own cost to provide a certificate that removal or destruction has occurred.

From the date of termination, the licence granted under this agreement also terminates.

#### 5. Governing Law

This agreement is governed by and must be construed in accordance with the laws of the State of New South Wales.
