In response to question 3. I am aware that ISO Standards can accessed via British Standards Online (BSOL). Access/subscriptions via the BSOL platform offers a number of benefits to libraries; including BSOL indexing in discovery layers, permission of deep linking, full text access being automatic (rather than additional yearly repurchase required in SAI Global individual standard unlocking), retention of the copy/e-copy of standards (as there is no destruct date as per SAI Global), and unlimited concurrent users.





Summary of NSW.net access to Standards Australia – via SAI Global online

Due to commercial in confidence NSW.net cannot provide information on the cost of access to Standards Australia, however NSW.net can confirm the following. Prior to the 2015/16 financial year and for 12 consecutive years, NSW.net fully subsidised a state-wide subscription to SAI Global's Standards Online Public Library Service. This subscription could only be accessed from within the library (i.e. no remote access) and access was provided to all NSW public libraries.

NSW.net concluded this state-wide subscription in June 2015 due to budgetary constraints and low use. Usage statistics for the 2014/15 financial year showed 9626 searches and 9747 full-text downloads.

In its place, NSW.net brokered a consortia offer for NSW.net public libraries to take up and continue this service at a discounted rate. Of the 101 NSW library services, 34 took up this offer. This offer was for a limited time only until 30 June 2015 and for a 12 month term.

ALIA Standards Australia survey 2015

Introduction


ALIA has been aware that the cost of providing equitable access to Standards Australia has been an issue for some libraries in Australia. In August 2015 we ran a survey of libraries to find out how widespread the problem may be, in advance of contacting the organisation to discuss possible options.

As the peak body for libraries in Australia, ALIA represents school, public, academic, TAFE, government, health, law, corporate and other special libraries. We have a close working relationship with National and State Libraries Australasia.

For this survey, we sought input specifically from public and TAFE libraries. There are approximately 1500 public libraries in Australia and 250 TAFE libraries.

Survey respondents

We received 32 responses from library services representing 5,019,854 library users.



The 'other' libraries were a State Library, a corporate library and a joint use school/community library.

Of the respondents, 32% subscribed to Standards Australia, all with a one year subscription.




Terms and conditions

Respondents who subscribed to Standards Australia did so in the following ways:

- 53% subscribed to the Premium Edition
- 20% subscribed to the Public Library Edition
- 20% subscribed to another edition
- 7% didn't know

Subscribers had different terms and conditions depending on their subscription.



These terms and conditions were an issue for 44% of those who subscribed to Standards Australia. Comments included:


- Generally onerous restrictions all round
- We do not subscribe due to the costs involved
- Unable to afford enough concurrent users to meet demand restrictions on where you can print restrictions on ability to use Standards in the online teaching environment




- Printing is time consuming and confusing to users when only 1 page can be printed at a time. We are a statewide network and are only able to serve clients onsite at a few locations instead of all our public library sites
- Too expensive for multiple concurrent users. A single concurrent user is limiting when TAFE are expected to deliver training that includes Australian Standards where required.
- Not available to Library patrons. Only available internally to Org with conditions applied.
- Confusing and contradictory statements about what lecturers and students can do especially in regards to printing and saving
- Have to pay full price to unlock a standard (12 months) and then renew on the due date.
 Double dipping. Cost to add additional users is high only 20% less on the price for just 1 user

Pricing

Subscription prices varied from \$5000 to \$75,000.




Affordability was an issue for 83% (24 of the 32 respondents).



Usage

Usage of Standards Australia was said to be higher in TAFE libraries than in public libraries but few libraries had hard data. For most, their response to this question was an estimate.



Other comments

- "Teachers unable to print copies for students teachers and students can only access and print a copy for their individual use"
- "Teachers cannot copy extracts or images from standards to include in learning resources"
- "Platform is not particularly user-friendly considering the cost of the service one would expect a premium product in all areas"
- "We have only rarely received enquiries about the availability of standards, we refer customers to the State Library"
- "We are no longer able to afford a sufficient number of licenses to meet demand, which now results in c14% unavailability"
- "I have had to resort to cost-sharing with other agencies though their threshold is also limited"
