These funds are used for the betterment of Aboriginal people. From 7 August 2013, intestate estates of Aboriginal people are no longer administered under Part IV of the <i>Aboriginal Affairs Planning Authority Act 1972</i> . The Intestate Trust Account will be wound down when all estates of Aboriginal people who died before 7 August 2013 have been distributed or otherwise have been dealt with by the Public Trustee.	\$0	Nil
