

Estimates and Financial Operations Committee 2016-17 Annual Report hearings - Questions prior to hearings

Department of Fire and Emergency Services

Hon Colin de Grussa MLC asked:

- Page 16 of the 2017 annual report twice refers to the Emergency Services Levy review in the context of Volunteer Marine Rescue Services and completion of the review by the Economic Regulation Authority. With regard to the ESL review, I ask:
 - (a) Is the Department aware of any potential planned response to the review from the State Government:
 - The State Government is currently considering the recommendations from the ERA review into the ESL.
 - (b) If yes to (a), has the Department been briefed on what this response may include; and
 - Please refer to (a)
 - (c) Has the Department indicated its support or opposition to any of the recommendations made in the ESL review to the Minister?
 - DFES' position (as articulated through these submissions) was provided to the Minister for Emergency Services and are available on the ERA website www.erawa.com.au
- 2. I refer to mention of a new Volunteer Hub being developed by the Department on page 27 of the 2017 annual report:
 - (a) On what specific date will this Volunteer Hub be complete and available for use by volunteers;
 - A pilot version of the Volunteer Hub is anticipated for release in the third quarter of 2018.
 - (b) How many members of the volunteer project team are from regional Western Australia: and

The Volunteer Working Group has 166 volunteers registered and 98 (59%) are from regional WA. All regions of WA are represented in the volunteer project team. It is an objective of the engagement strategy to ensure regional volunteers are involved in the project.

(c) What considerations are being given to regional volunteers who may have difficulty accessing the Hub due to poor or no internet coverage?

This has been a key consideration in development of the Volunteer Hub. Regional volunteers have provided significant input into the development of the hub and how it will be structured including consideration to internet difficulties in regional WA. The Volunteer Hub is being designed to be accessible on both computers and mobile devices as volunteers have indicated that they commonly use mobile devices to access the internet. The Volunteer Hub has also been designed so that volunteers can choose to use a low bandwidth version of content which will reduce demand on low bandwidth connections as experienced in some areas of regional WA. Additionally, the design of the volunteer hub aims to accommodate poor internet coverage by limiting the size of large images and media files and listing the size of documents to ensure a user is aware of the amount of download required and allow them to decide whether they want to download the file or not.

Project resources have been allocated to ensure the good performance of the site across a range of network conditions. The bandwidth required for static web content is being minimised using industry best practice. Regional volunteers will be involved in testing and piloting the site.

In addition, DFES is currently working to ensure that volunteers have access to training material and support regardless of geographic location.

(c) The total number of positions required to be cut by the Department as part of the State Government's Voluntary Targeted Separation Scheme; and

The Voluntary Targeted Separation Scheme (VTSS) is a Budget repair tool to assist agencies in meeting Machinery of Government (MoG) savings resulting from the amalgamation of a number of government departments as well as assist in achieving workforce renewal by enabling agencies to retain 20% of the savings. The VTSS is open to

all general government employees, though priority is being given to agencies impacted by the MoG changes (which took effect from 1 July 2017).

Agency targets are Cabinet-in-confidence and were provided as a guide to assist agencies and Ministers with implementation of the scheme. While the reductions will vary between agencies depending on factors like MoG changes, the size and role of individual agencies and other impacts, all agencies are expected to contribute in order to meet the overall reduction target of 3,000 employees.

Agencies are currently working with the Public Sector Commission to progress the scheme via individual expression of interest (EOI) processes. The agency EOIs are currently at various stages, with all exits expected to occur by 31 March 2018. Progress will be reported to Cabinet during the 2018-19 Budget process, with the aim of achieving the 3,000 separations and reflecting the actual savings and costs from the VTSS in the 2018-19 Budget.

- 5. I refer to recruitment section on page 178 of the 2017 Annual Report and I ask:
 - (a) What is the Department doing to encourage those unsuccessful in applying for a full-time firefighting position, due to oversubscription, to take up volunteer emergency service roles in the community;

In the 2016 firefighter recruitment process, over 350 applicants (in excess of 30%) identified that they had been or were actively involved in emergency services volunteering.

Depending on the elements in which they were unsuccessful, applicants who request feedback on their overall application may be encouraged to consider active involvement in the community, including the option of becoming an emergency services volunteer. While this approach does not guarantee an increase in competitiveness, previous experience or training in volunteer emergency services may enhance an applicant's performance in some recruitment stages.

(b) What apprenticeship options are available through the Department; and

DFES has a Radio Communications apprenticeship in the field of electronics. DFES works with apprenticeship organisations and offers placements to apprentice mechanics at its O'Connor workshops however due to the specialised nature of its workshops, an apprenticeship completed solely through DFES does not provide the necessary scope of experiences.

(c) Are contracted services bound by the same diversity policies as recruitment of agency staff?

Non-employees are not specifically bound by DFES' diversity policies.

- 6. Page 149 of the 2017 annual report outlines 13 per cent of the Department's assets are outside the specified replacement period.

The KPI on page 149 does not refer to assets (neither facilities nor fleet) that required replacement as at 30 June 2017. It does, however, refer to specified replacement period parameters that DFES uses as a proactive guide for its asset management program.

Any assets deemed no longer fit for purpose are decommissioned and disposed of regardless of replacement term.
