PATS information to Public

- PATS information is made available to the public through the WACHS PATS pamphlets as well as the 'My Travelling Booklet' which is aimed at indigenous patients
- For non-English speaking patients, an interpreter is sourced, which we have done numerous times for a patient whom only speaks Turkish.
- The majority of people seeking information call the PATS office for advice, which PATS officers provide.

Luggage allowance

• Luggage – for those flights where luggage is not included in the fare, we buy a luggage allowance on behalf of the patient.
