

Question No.B3: Hon K. Travers asked -

Can the parliamentary secretary answer why there is a difference in the way in which development commissions report and whether it is something that the government is looking at to try too streamline it and bring it into a consistency across the presentation of budget papers?

Answer:

Recommendation 7 of the Report of the Economic Audit Committee recommended that the Department of Treasury and Finance (DTF) modify the existing performance reporting regime. Specifically part (c) of that recommendation looks at developing consistent KPIs for facilitative roles that are common across similar functions (for example, compliance with legislation, grant administration costs).

The inconsistency of the current reporting arrangements by Regional Development Commissions will therefore be addressed as part of the DTF responding to that recommendation. DTF is not in a position as yet to advise of the timeframe for action relating to this recommendation.

This matter has also been referred to Mr Mike Rowe, A/Director of Regional Development and Operations, Department of Regional Development and Lands, to discuss with the Chief Executive Officers of the Regional Development Commissions to explore how consistent performance reporting by all Commissions might be achieved.
