- The Second Strike Notice is issued where a substantiated incident of disruptive . behaviour has occurred and there has been one other substantiated incident of disruptive behaviour in the previous 12 months.

A7) The response provided on 15 August 2017 indicated there was an increase of 2 234 additional properties added to the public housing system since the end of 2010-11, and identical information contained in the ROGS data identifies a decline of 307.

Can the minister provide clarification regarding the reason for the difference?

Answer:

Question without notice No. 378 provided the Member with the gross number of public housing properties that have been added to the affordable housing system since the end of 2010-11.

2,234 is a gross figure and includes all new completed public housing dwellings, constructed or acquired. All of these dwellings are owned by the Housing Authority but some of them are managed by community housing providers under a head lease agreement.

The ROGS numbers represent the number of properties used for public housing within the previous 12 months. That is, managed by the state housing authority and provided to subsidised rental tenants. This excludes any government owned dwellings managed by community housing organisations on behalf of government for the purposes of helping social housing tenants. The disparity between the numbers essentially relates to ownership versus management of dwellings.

A9) In regard to the Housing Authority's public housing stock redevelopment strategy, can the minister provide the following:

(a) The number of public housing dwellings in total that were sold and demolished under the strategy?

Answer: Public Housing dwellings demolished in the Public Housing Stock Redevelopment Program numbered 101. There have been no public housing dwellings sold under this program to date.

(b) The number of public housing dwellings that were built to replace those properties sold or demolished under the strategy?

Answer: 102

(c) Were all the properties sold or demolished under the strategy replaced with new dwellings in the public housing system?

Answer: Yes

(d) Did the Housing Authority succeed in building and selling 500 affordable properties as was anticipated?

Answer: The Housing Authority built 502 new dwellings for sale as affordable homes. As at 24 October 2017, 480 have been sold, 22 are currently for sale.

(e) If so, how many were sold at market price and how many were sold as a shared-equity housing product?

Answer: Of the 480 dwellings sold, 240 were shared equity and 240 were full market sales.

(f) It was estimated that the delivery of the 500 properties under the program would be cost neutral after receipt of sales revenue. Can the minister confirm that this was the case?

Answer: Yes it was cost neutral.

(g) Has the strategy at this stage made a profit or a loss?

Answer: The strategy has made a profit.
