## Chair's Foreword

It is indeed a privilege to chair a standing committee which has portfolios of such importance, and having by far the largest budget demands, in Education and Health.

In our beginnings following the 2013 election, we have been keen not to launch into large and cumbersome inquiries at the outset, but to continue to ensure that the processes and expenditure of these large agencies meet best practice standards and provide best value for taxpayers.

In the Health area, we have been eager to explore this, but without a full-blown inquiry into the Health Department, who are currently managing the completion and commissioning of the large Fiona Stanley Hospital project. Of interest to us also are the management of the delayed opening and the implications arising from that.

In the area of Education, the management of the Budget, with the announcement of a new funding structure for Western Australian schools, and the implications for education programmes and entitlements, has been our focus.

With the ever increasing incidence of mental illness in young people and high suicide rates in the future, the committee is keen to explore how a young person falling ill or with induced mental illness is handled by a mental health system and what changes are needed.

We look forward to targeted investigations to make changes that improve service and get good value for the tax payer's dollar.

# Chapter 1

## Committee activities

### Introduction

This report covers the work undertaken by the Education and Health Standing Committee for the financial year 2012–2013. The Committee was prorogued on 14 December 2012 with the Legislative Assembly. The Assembly was dissolved on 30 January 2013. The State general election was held on 9 March 2013. This created an interregnum until the formation by the Legislative Assembly of a new Education and Health Standing Committee on 9 May 2013.

During the 38<sup>th</sup> Parliament, the period between 1 July 2012 to 14 December 2012, the Education and Health Committee:

- conducted one inquiry;
- tabled four reports;
- held ten deliberative meetings;
- took evidence from 21 witnesses at five hearings; and
- did not undertake investigative travel or attend any conferences.

During the 39<sup>th</sup> Parliament, the period between 9 May 2013 and 30 June 2013, the Committee:

- held five deliberative meetings;
- took evidence from eight witnesses at two hearings;
- did not conduct any inquiries or table any reports; and
- did not undertake investigative travel or attend any conferences.

## Chapter 1

### **Work in progress**

In the 39<sup>th</sup> Parliament, the Education and Health Standing Committee has held hearings with the Department of Health and the Department of Education in order to gather information to inform possible future inquiries. The Committee has used these hearings to examine the delayed opening of the Fiona Stanley Hospital, and to acquaint itself with the budget positions of both the Department of Health and the Department of Education.

Over the coming months, the Committee may follow up with agencies regarding the status of recommendations made in the previous Committee's reports.

## Chapter 2

### Financial statement

The Education and Health Standing Committee does not have its own formal budget and is funded out of the budget of the Legislative Assembly. Approval for major expenditure is required on a case-by-case basis and is entirely at the discretion of the Speaker.

# Appendix One

## Committee's functions and powers

---

The functions of the Committee are to review and report to the Assembly on:

- a) the outcomes and administration of the departments within the Committee's portfolio responsibilities;
- b) annual reports of government departments laid on the Table of the House;
- c) the adequacy of legislation and regulations within its jurisdiction; and
- d) any matters referred to it by the Assembly including a bill, motion, petition, vote or expenditure, other financial matter, report or paper.

At the commencement of each Parliament and as often thereafter as the Speaker considers necessary, the Speaker will determine and table a schedule showing the portfolio responsibilities for each committee. Annual reports of government departments and authorities tabled in the Assembly will stand referred to the relevant committee for any inquiry the committee may make.

Whenever a committee receives or determines for itself fresh or amended terms of reference, the committee will forward them to each standing and select committee of the Assembly and Joint Committee of the Assembly and Council. The Speaker will announce them to the Assembly at the next opportunity and arrange for them to be placed on the notice boards of the Assembly.
