increasingly demonstrating serious signs of dysfunctionality, and calls on the Government to urgently address the issues raised by the Corruption and Crime Commission and refocus its attention on restoring public confidence in the capacity of the Government to govern for all West Australians without fear or favour.

The Clerk is authorised to provide a list of names, identified by the Committee, to the Corruption and Crime Commission.
