58. Select Committee on Memorandum of Understanding Between Balga Senior High School and Manufacturing Industry Training Services Pty Ltd - Establishment (*Notice given 3 April 2007*)

Continuation of remarks Minister for Local Government (Wednesday, 20 June 2007) on the motion of Hon Peter Collier as follows -

That -

- (1) A select committee of three members is appointed, any two of whom constitute a quorum.
- (2) The committee is to inquire into and report on -
 - (a) the circumstances surrounding the signing of the Memorandum of Understanding between Balga Senior High School and Manufacturing Industry Training Services Pty Ltd on 14 February 2005 for the establishment of the Balga Works Programme;
 - (b) the knowledge and involvement of Government Ministers, officers of the Department of Education and Training and officers of all other government and Ministerial offices in the circumstances surrounding the signing of the Memorandum of Understanding as referred to in (a);

- (c) the circumstances surrounding the replacement of the Manufacturing Industry Training Services Pty Ltd with Herson Pty Ltd as the operators of the Balga Works Programme in 2005;
 - (d) the knowledge and involvement of Government Ministers, officers of the Department of Education and Training and officers of all other government Ministerial officers in the circumstances surrounding the operation of the Balga Works Programme 2004-2007;
 - (e) the circumstances surrounding the payment and non-payment of former employees of the Balga Works Programme;
 - (f) the circumstances surrounding the funding of accommodation for young people provided under the Balga Works Programme at Nottingham Street, Joondalup by the Department of Community Development 2004-2007; and
 - (g) such other relevant matters as the committee considers appropriate.
- (3) The committee has the power to send for persons, papers and records and the power to travel.
 - (4) The committee may present interim reports without a requirement for leave.
 - (5) The committee is to report to the house no later than Thursday, 6 December 2007.

- (2) Consider whether alternative or additional reforms to those proposed by the first Commission on Government are required to prevent corrupt, illegal or improper conduct by public officials (including State Members of Parliament, Local Government Councillors and employees of State and Local Governments);
- (3) Carry out its inquiries in an open and participatory manner; and
- (4) Report to both Houses of Parliament within one year from establishment of the Commission.

54. Kojarena Satellite Ground Station - Expanded Function (*Notice given 21 March 2007*)

Hon Giz Watson: To move -

That this House -

- (1) Notes that the Federal Government has announced an expanded function of the joint US spy satellite ground station at Kojarena near Geraldton.
- (2) Notes that this expanded function will coordinate US military operations in the Middle East and Asia, making this the most significant military encroachment into Australia since signing of the Pine Gap Treaty of 1966.
- (3) Condemns the Federal Government for committing to this expanded function without consulting with the people of Western Australia, the City of Geraldton and the Premier.

- (c) Tele-health capacity would enable quality health services to be delivered via a broadband network to areas where such services are currently impossible; and
- (d) the use of the Future Fund to enable public investment in the national broadband network is a valid and essential means of achieving the aims of the Fund by investing in Australia's future in commerce, education and health.

- (2) The Committee, and the proceedings of the Committee, are subject to Chapter XXII of Standing Orders and it is to be regarded for all purposes as a committee appointed under that Chapter.
- (3) The Committee may present interim reports without a requirement for leave and is to report finally not later than 30 March 2007.

Extension of reporting date granted to 28 June 2007 (7 December 2006).

103. Select Committee of Privilege on a Matter Arising in the Standing Committee on Estimates and Financial Operations - Establishment (*Established 21 March 2007*)

On the motion of Hon Giz Watson, as amended, as follows -

That -

- (1) A Select Committee of Privilege be appointed to inquire into and report on -
 - (a) whether there has been any disclosure of deliberations of the Standing Committee on Estimates and Financial Operations relating to a proposed inquiry into the State's Iron Ore industry;
 - (b) if so, whether such disclosure constitutes a breach of the privileges, or is a contempt, of this House; and
 - (c) if the Committee so finds, what penalty, if any, the House might impose for the breach or contempt.
- (2) The Committee have access to documents in the possession or under the control of the Standing Committee on Estimates and Financial Operations relevant to the inquiry.
- (3) The Committee have power to send for persons, papers and records and to travel from place to place.
- (4) The Committee have power to meet at any time when the Legislative Council is not sitting or a sitting is suspended.

- (5) The Committee may present interim reports without a requirement for leave and is to present its final report to the House not later than Wednesday, 30 May 2007.
