8. Select Committee into the Fremantle Eastern Bypass - Establishment

Motion No. 5 having been called.

Debate resumed on the amendment of Hon Norman Moore as follows -

That the words "That a Select Committee of five Members is appointed, any three of whom constitute a quorum" be deleted and the following words be substituted -

- "That the Standing Committee on Public Administration and Finance be required", to the motion of Hon Simon O'Brien as follows -
 - (1) That a Select Committee of five Members is appointed, any three of whom constitute a quorum, to inquire and report on the history of that part of the Metropolitan Region Scheme known as the Fremantle Eastern Bypass and related road infrastructure including -
 - (a) initial inclusion of the bypass in the Metropolitan Region Scheme;
 - (b) subsequent modifications to the Metropolitan Region Scheme in respect of the bypass;
 - (c) the decision making process and advice given to Government by relevant Government agencies including agencies responsible for Main Roads, Planning, Transport and Environment;
 - (d) directions given by Government to agencies with responsibility for decision making; and
 - (e) other matters pertaining to the history and possible future of the Fremantle Eastern Bypass that the Committee may consider useful to bring to the attention of the House.
 - (2) The Committee have power to send for persons, papers and records and to travel from place to place.
 - (3) Standing Orders 322, 323, 330 and 331 apply to the proceedings of the Committee and any contrary or inconsistent provision of Chapter XXIII is modified accordingly.
 - (4) The Committee may present interim reports without a requirement for leave is to report finally not later than November 30 2002.

9. Statement by President - Answer to Question with Reference to a Legislative Assembly Hansard Report

The President made the following Statement -

Since the last sitting of this House, I have considered question without notice 289 and the answer to the same. Hon Norman Moore asked -

"I refer the Minister to the views of Dr Gallop in 1997 on the legislation to give the President of the Legislative Council a deliberative vote, when he said that any such proposal was a cynical attempt to subvert the will of the people.

- (1) How does the Minister reconcile this complete about-face by the Labor Party on this issue when there has been no effort by the Government to ascertain that the will of the people has changed since 1997?
- (2) Why did the Labor Party's view of the proposal represent a subversion of the will of the people in 1997 but does not do so in 2002?"

Hon Nick Griffiths, being the Minister present on Thursday, October 24, replied -

- "I thank the Member for some notice of this question. The Minister has provided the following answer -
- (1-2) I refer the Member to Premier Gallop's answer in *Hansard* dated October 17 2002 to parliamentary question No. 215."

I draw Members' attention to Standing Order No. 94, which is taken to apply to references to any proceedings in another place. Not only is it discourteous to this House to answer a question in terms of a Legislative Assembly *Hansard* reference, but it is also out of order.
