- (d) when evaluating the cost of power usage between evaporative and reverse-cycle units, will consideration be given to the difference, given the reverse-cycle units will eliminate the need for gas heating which will void the need to frequently purchase gas cylinders in the winter?

In relation to the recent increase in fruit flies in the horticultural industry in Carnarvon, I ask:

- (a) what role does the Department of Agriculture (the department) have in the control of fruit fly in the Gascoyne region;
- (b) what role does the Federal Agriculture Department have in the control of fruit fly in the Gascoyne region;
- (c) what role does the Carnarvon Growers Association (CGA) have in the control of fruit fly in the Gascoyne region;
- (d) does the State government receive any funding from the Federal Government for the control of fruit fly;
- (e) if yes to (d), how much and is the funding recurrent;
- (f) what funds are available to the Gascoyne region for fruit fly control from the State government;
- (g) has there been an increase in funding to the CGA in the past two years;
- (h) how much funding does the CGA receive for their role in the fruit fly control program;
- (i) who carries out the following functions for fruit fly control in the Gascoyne Region;
 - (i) administration of the program;
 - (ii) supervision for the delivery of the project; and
 - (iii) monitoring the effectiveness of the fruit fly control program;
- (j) how is the effectiveness of the fruit fly control program monitored; and

(k) is the baiting carried out by volunteers, and if not, who is employed to do the baiting?

6793. Mr A.P. O'Gorman to the Minister for Transport

- (1) At the intersection of Joondalup Drive/Shenton Avenue in Joondalup how many infringements have been issued since the red light camera was installed?
- (2) At the intersection, how many infringements have been issued since the speed camera was installed?
- (3) What is the total revenue raised from the red light camera at the intersection in Joondalup since it was installed?
- (4) What is the total revenue raised from the speed camera at the intersection in Joondalup since it was installed?
- (5) In terms of the revenue for the red light camera and the speed camera can the Minister please advise:
 - (a) specifically where has the revenue been allocated;
 - (b) for what specific purpose;
 - (c) is any of the revenue being spent on road safety initiatives; and
 - (d) if so, what percentage of the revenue has been allocated to road safety measures?
