- (b) which organisations are the main participants in the programme and what role do they play in the funding, administration and provision of housing under the programme; and
- (c) what are the normal procedures for clients applying for housing under the programme?

6206. Mr M. McGowan to the Minister for Transport

I refer to Question on Notice 5850 regarding the 3,285 parking tickets issued for the financial year 2010–11 at the Rockingham, Warnbro, Mandurah and Stirling train stations, and ask, could the Minister provide a breakdown of the number of parking tickets issued at each of the train stations mentioned above?

I refer to Question on Notice 5848 regarding a publicly accessible database of State Government boards and committees, and your response that an interim list was recently temporarily withdrawn from that website to be updated and will be restored shortly, and ask:

- (a) on what date was the interim database withdrawn;

In relation to the welcome pack being prepared by your Government for official guests and delegates to Commonwealth Heads of Government Meeting, I ask:

- (a) what is the cost of the welcome packs and how many are being produced;
- (b) will the welcome packs includes condoms and advice on safe sex practices;

- (c) will the welcome packs include information on equality and anti-discrimination laws in Western Australia, that preclude discrimination against lesbian, gay and transgender Western Australians; and
- (d) will visiting Heads of State and other delegates be subject to Western Australian laws if they discriminate against Western Australians during their visit?

6209. Mr A.P. O'Gorman to the Minister for Health

- (1) How many patients from the Joondalup Health Campus were transferred from Joondalup to another facility, either public or private, for the purposes of receiving an angiogram over the past twelve months?
- (2) What was the cost of transferring those patients via ambulance to other facilities?
- (3) How many patients returned positive angiograms that required further medical intervention?
- (4) What was the cost of those further treatments?
- (5) Is there an alternative less invasive procedure to an angiogram to determine blockages to the blood vessels?
- (6) If there is an alternative to an angiogram is that test available in the public health system in Western Australia?
- (7) What is the cost of the alternate test compared to the cost of an angiogram?
