That this House condemns the Labor Government for dangerously under resourcing the health system at Perth Children's Hospital which underpinned the tragedy surrounding Aishwarya Aswath, and calls for the Minister for Health to resign for failing to acknowledge and act on the warnings from health workers, the Australian Medical Association and the Australian Nurses Federation.
