2944. Dr J.M. Woollard to the Minister for Employment Protection

A 2004 report published within the *Australian Journal of Soil Research* stated that an audit of 6,500 premises in Western Australia with dangerous goods had revealed that 57 per cent of these premises contained underground storage tanks, approximately half of these tanks were situated within Perth, and 217 were leaking pollutants. These statistics were printed in the Government's 2007 *State of the Environment Report*. With reference to these reports, I ask the Minister:

(e)	how many leaking underground storage tanks have been fixed since 2004 in: (i) metropolitan Perth; and (ii) rural and regional Western Australia?
