#### 1. Meeting of Council

The Council assembled at 11.00am pursuant to order.

The President, Hon Nick Griffiths, took the Chair and read prayers.

### 2. Statement by President - Hon Shelly Archer - Fitness to be a Member of Parliament

The President made the following Statement -

Honourable Members, I have a message from the Legislative Assembly. However, before I read the message, I should advise the House of the practice of this Parliament over many years. In a bicameral, Westminster-type Parliament, it is a fundamental principle that neither House involves itself in, or formally notices, what occurs in the other. Standing order 97 provides -

No Member shall use offensive or unbecoming words in reference to any Member of either House, and all imputations of improper motives and personal reflections on Members shall be considered highly disorderly, and when any Member objects to words used, the presiding officer shall if he considers the words to be objectionable or unparliamentary, order them to be withdrawn forthwith.

This reflects that principle, as does the expression "another place", rather than referring to the Assembly by name in debate. Standing order 94 states -

No Member shall allude to any debate of the current session in the Assembly, or to any measure impending therein.

These and related principles are intended to maintain "comity between the Houses" and avoid deleterious relationships between the two. The Parliament should function in an orderly manner to promote the "peace, order and good government of Western Australia". It involves each House respecting the independence of the other. This House should not entertain the message in order for this House to uphold those principles.

Message No 276 from the Legislative Assembly states -

The Legislative Assembly advises the Legislative Council that the following motion was passed without dissent.

That this House considers that Hon. Shelley Archer is not a fit and proper person to be a Member of Parliament.

The words "without dissent" lack precedent and are grossly inappropriate. I rule the message out of order.
