# 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

## 2. Statement by President — Members' Luncheon

The President made the following Statement —

Members, before we start today, as we are aware, today is an additional sitting day. Arrangements have been made for the lunchbreak today, which will occur between 12.30pm and 2.00pm. Members may not be aware that the Members' dining room is unavailable today due to a longstanding booking, so a carvery has been set up for the Legislative Council Members only in the Members' lounge opposite the dining room. Hon Simon O'Brien presented a petition from one petitioner requesting the Legislative Council to investigate concerns in relation to the Fremantle Council oversight of the Local Government owned Fremantle Markets, and the financial and management disadvantage to many small business tenants. The Order of the Day for the further consideration of this Bill, in Committee of the Whole House, having been read.

Hon Adele Farina moved —

Page 36, after line 23 — To insert:

- (2A) At the time of prescribing a voluntary assisted dying substance for the patient, the coordinating practitioner must inform the patient about the following matters
  - (a) the schedule 4 and/or schedule 8 poisons constituting the prescribed substance;
  - (b) the method by which the prescribed substance is to be self-administered;
  - (c) how to prepare and self-administer the prescribed substance;
  - (d) the expected effects of ingesting the prescribed substance;
  - (e) the expected time to death after ingestion;
  - (f) the potential risks of self-administrating the prescribed substance.

Debate ensued.

Hon Adele Farina, by leave, withdrew her amendment.

Debate resumed.

Hon Rick Mazza sought leave to defer consideration of amendments 420/57 and 421/57 until a later stage of clause 57.

Leave granted.

Hon Nick Goiran moved —

Page 37, lines 1 to 2 — To delete ", the contact person for the patient or an agent of the patient." and insert:

or the contact person for the patient.

Debate ensued.

Hon Nick Goiran, by leave, withdrew his amendment.

Hon Rick Mazza moved —

Page 37, lines 3 to 18 — To delete the lines and insert:

- (4A) The administering practitioner for the patient is authorised to
  - (a) receive the prescribed substance from an authorised supplier; and
  - (b) possess the prescribed substance for the purpose of supplying it to the patient; and

- supply the prescribed substance to the patient immediately before the patient is ready to self-administer the prescribed substance if the administering practitioner is satisfied at the time of supply that
  - (i) the patient has decision-making capacity in relation to voluntary assisted dying; and
  - (ii) the patient is acting voluntarily and without coercion; and
  - (iii) the patient's request for access to voluntary assisted dying is enduring.
- (5) The patient is authorised to
  - (a) receive the prescribed substance from the administering practitioner for the patient immediately before the patient is ready to self-administer the prescribed substance; and
  - (b) possess the prescribed substance for the purpose of preparing and self-administering it; and
  - (c) prepare the prescribed substance; and
  - (d) in the presence of the administering practitioner for the patient and a witness, self-administer the prescribed substance.

Debate ensued.
