# THURSDAY, 17 JUNE 2021 10.00am

#### 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Alanna Clohesy, took the Chair.

Prayers and an Acknowledgement of Country were read.

Hon Donna Faragher presented a petition from 20 petitioners requesting the Legislative Council to provide guaranteed equitable access to a dynamic, well-resourced library including access to a qualified teacher librarian and a library technician or library officer for Western Australian schools.
