## 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

# 2. Statement by President — Mental Health Month

The President made the following Statement —

Mental Health Month occurs each year in the month of October. Last week, 6 to 12 October, was Mental Health Week in Western Australia, which coincided with World Mental Health Day, observed on 10 October. Mental Health Month is an important opportunity to bring mental health out in the open and to improve understanding of mental health issues. Parliament House was illuminated orange last night, and will continue to be through to Sunday, to promote Mental Health Month and improve community awareness and interest in mental health and wellbeing.

Members, you should have received a Black Dog Institute pin and information on mental health. I encourage you to wear the pin and to make the information available in your electorate offices for constituents. We should all understand the importance of mental health in our everyday lives and encourage help-seeking behaviours when needed.

# 6. Regional Healthcare

Hon Martin Aldridge: To move on the next day of sitting —

That the Legislative Council acknowledges the disparity that exists between metropolitan and regional Western Australia with respect to healthcare and calls on the State Government to:

- (a) implement strategies to improve healthcare in regional Western Australia;
- (b) appoint a Rural Health Commissioner to deliver better information and transparency and most importantly to drive innovation and reform in healthcare and population health generally;
- (c) immediately increase and modernise the Patient Assisted Travel Scheme (PATS) to better support those required to access specialist and allied health services; and
- (d) ensure palliative care is accessible across regional Western Australia.

#### 7. Government Transparency and Accountability

Non-Government Business No. 1 having been called, Hon Dr Steve Thomas moved, without notice — That this House:

- (a) notes the promise of the Premier that his Government would deliver a gold standard of transparency and accountability;
- (b) notes the many occasions in which the McGowan Government has failed to deliver on the Premier's promise; and
- (c) calls on the Premier to finally deliver on his promise by raising his Government's standards of transparency and accountability to a gold standard so that the Parliament and the community can be assured this administration is operating in an open, accountable and honest manner.

# 11. Statement by President — Clerk of the Cook Islands

The President made the following Statement —

I would like to formally welcome the Clerk of the Cook Islands Parliament, Mr Tangata Vainerere, to the Parliament of Western Australia. The Parliament of Western Australia has a longstanding twinning arrangement with the Cook Islands Parliament spanning over 25 years. During this time, we have engaged in capacity building and knowledge sharing across the two parliaments.

Tangata, or Ta, as he is better known, was appointed Clerk of the Cook Islands Parliament on 16 November 2018 having previously been the executive director of the Pacific Legislatures for Population Governance. Ta has also served as Clerk of Committees and as the secretariat for Parliament's Public Accounts Committee.

Ta joins us this week on a professional development attachment whereby he has been immersed in procedural, committee and administrative matters. In recognition of his status as Clerk, Ta has joined us at the Clerk's table to observe question time. On behalf of all Members, I welcome Ta to our Chamber.
