- (e) how much advertising revenue was achieved from billboards at the Mt Lawley underpass and nearby railway reserve land in 2010–2011, and so far in 2011–2012; and
- (f) what is the budgeted income from the Mt Lawley underpass and nearby railway reserve land in 2011–2012, and future forward estimates years?

7871. Mr R.H. Cook to the Minister for Health

I refer to the plan for all clinical services at Princess Margaret Hospital (PMH) to be moved to the new Children's Hospital upon completion of the new hospital in 2015, and ask:

- (a) what is the Department for Health's plans for the future of the PMH site once the new hospital is completed in 2015, and clinical services have been moved across;
- (b) has the Office of the Valuer General and/or a private land evaluator provided an estimate on the land value of the PMH site and, if so, what is the most recent estimated value of the site;

- (d) is the construction for the new hospital contract linked to the opportunity costs in redeveloping the old site;

7872. Mr R.H. Cook to the Minister for Health

I refer to the story in *The Sunday Times* on 8 April 2012, where it was revealed that the Western Australian Health Department identified that 39% of 562 stores surveyed had sold cigarettes to minors posing as adults last year. As it is an offence under the *Tobacco Products Control Act 2006* to sell cigarettes to minors, can the Minister advise:

- (a) what mechanisms will the Minister put in place to ensure that those responsible are prosecuted for breaking the law; and

- (b) has the Department written to the offending stores identified through the survey advising them of their obligations under the *Tobacco Products Control Act 2006*, particularly with respect to minors, and reminding them of the penalties for non-compliance, and, if not, why not?

7873. Mr J.N. Hyde to the Minister for Corrective Services

- (a) on what date was the publicly identified 14 year old Indonesian child, Ali Yasmin, moved from Hakea adult maximum security prison to Albany adult prison;
- (b) how many other suspected young Indonesian prisoners were moved to Albany adult prison at or about the same time;
- (c) on what dates did the Minister receive the two pieces of official correspondence regarding Indonesian prisoners referred to in Question on Notice No. 4793;
- (d) on what dates did the Minister receive any reports or information via the Inspector of Custodial Services relating to information from Independent Visitors Scheme members regarding under-age Indonesians in Western Australian adult prisons; and
- (e) since 2009, on what dates were any Indonesians moved from Hakea to Albany adult prison?

7874. Mr R.H. Cook to the Minister for Health

- (1) How many operating theatres are currently located at Princess Margaret Hospital (PMH)?
- (2) What is the total number of operating theatre beds at PMH?
- (3) What is the average number of surgical procedures undertaken per day at PMH?
- (4) What is the maximum number of surgical procedures able to be undertaken at PMH on any given day?
- (5) How many operations have been undertaken per annum at PMH, since 2008?
- (6) What is the average cost to the Department of Health per surgical procedure (including staffing costs)?
- (7) With regard to the increase in rates of childhood obesity:
  - (a) what are the maximum weight limits on beds at PMH;
  - (b) how many of PMH's 220 total beds are able to accommodate children who require adult size/weight beds; and
  - (c) how many beds in PMH's operating theatres are able to accommodate children who are adult weight and/or size?

7875. Mr J.N. Hyde to the Attorney General

I refer to the Attorney General's answer in Question Time on 16 November 2010 concerning my statements that under-age Indonesians were being incarcerated in Western Australian adult prisons, where he stated that if he, or anyone in Government, ever receives any information that is even suggestive of the fact that someone might be under-age, it is handed to the appropriate authorities. In relation to this, I ask:

- (a) since the election of the Barnett Government, on how many occasions has the Government (as indicated in the answer to the question noted above) received information suggesting that a prisoner may be under-age;
- (b) on what exact dates, and on how many occasions, have concerns been relayed to the appropriate authorities and which authorities were these;
- (c) why did the Government, when alerted in 2010 to the under-age of the (now proven) then 14 year old Ali Yasmin, merely move him from adult high security Hakea to

adult high-security Albany and not advocate for his immediate removal from adult prison?

7876. Mr J.N. Hyde to the Minister for Corrective Services

I refer to the Minister's answer to my Question on Notice No. 5151 on 17 May 2011, where he stated that he is aware of multiple cases where current prisoners have alleged to be under-age, but that all cases (as at 18 April 2011) have been re-confirmed as at least 19 years of age or older by the Department in consultation with the Australian Federal Police. In relation to this, I ask:

- (a) exactly how many cases of alleged under-age prisoners was the Minister made aware of, and on what dates; and
- (b) will the Minister please detail exactly (and table all documents showing) how the Department re-confirmed that all current prisoners were at least 19 years of age, including birth certificates, official translations, personal visits to families, etcetera?

7877. Mr R.H. Cook to the Minister for Health

- (1) How many unfilled vacancies currently exist for full-time equivalent (FTE) dentists in the state's public dental services (including school clinics), listed by service?
- (2) What is the average salary provided to FTE dentists in the state public dental service?
- (3) How many unfilled vacancies currently exist for dental nurses existing in the state's public dental services (including school clinics), listed by service?
- (4) How many unfilled vacancies currently exist for FTE dental assistants in the state's public dental services (including school clinics), listed by service?
- (5) What is the average salary provided to a dental assistant in the state's public dental service?
- (6) How many vacancies exist for dental technicians in the state's public dental services (including school clinics), listed by service?
- (7) What is the average salary of a dental technician in the State's public dental service?
- (8) What is the longest amount of time any current patient still awaiting treatment from the state public dental service has waited, to date?
- (9) How many patients currently on the public dental list have already waited longer than 12 months?
- (10) What is the estimated total cost, in terms of new or additional funding required, for the reclassification of dental assistants to a level 2/3?
- (11) What is the estimated total cost, in term of new or additional funding that would be required, for moving dental technicians to a specified calling allowance?
- (12) (12) What progress (if any) has been made with respect to a formal offer for dental staff in state public dental services?
- (13) What progress has been made with respect to the rolling out of computers and staff training to school dental clinics, and is this still on track to be delivered by the end of the calendar year?

7878. Mr R.H. Cook to the Minister for Health

- (1) How many patients are treated on average per annum at each hospital emergency department in the South Metropolitan Area (please separately list figures for each hospital)?
- (2) How many full-time equivalent (FTE) staff are presently employed in the Emergency Departments at each hospital in the South Metropolitan Area (please separately list figures for each hospital)?
- (3) What are the current annual recurrent costs of operating the Emergency Departments at each hospital in the South Metropolitan Area Health Service (please separately list figures for each hospital) ?

- (4) What are the projected staffing levels proposed for the Emergency Department at the new Fiona Stanley Hospital?
- (5) When Fiona Stanley Hospital opens, and the Government intends to close Fremantle's Emergency Department, will all existing staff at Fremantle Emergency Department be offered employment at Fiona Stanley?
- (6) Will any staff unwilling to transfer to Fiona Stanley from Fremantle be offered alternative employment within the Department of Health?
- (7) If the projected staffing requirements for Fiona Stanley Emergency Department are unable to be met by staff transferring from Fremantle and external recruitment, will the result be reduced emergency department staffing levels at Rockingham and/or Armadale Hospitals?

7879. Ms M. M. Quirk to the Minister for Transport

- (1) What is the cost of producing a driver's licence card (per item)?
- (2) Is the production carried out within the Department of Transport or by a private contractor?
- (3) If production is carried out by a private contractor, is that contractor paid per piece or on some other basis?
- (4) If production is carried out by a private contractor, will the Minister please provide the name and details of the contractor and the duration of the contract?
- (5) What is the total cost of the contract?

7880. Ms M. M. Quirk to the Minister representing the Minister for Electoral Affairs

- (1) What is the total cost incurred annually by the Western Australian Electoral Commission (WAEC) in maintaining the Western Australian electoral roll?
- (2) What components make up this cost?
- (3) How many full-time equivalents in the WAEC are retained solely for this purpose?
- (4) At what level are those positions?

7881. Mr R.H. Cook to the Minister for Health

- (1) For each hospital that treats public patients and which has existing services delivered by the private sector, please list by hospital:
  - (a) which services are delivered by the private sector;
  - (b) which private company has the tender for each of these services; and
  - (c) what is the cost to the State Government for each of these services?
- (2) Which hospitals (including those presently under construction) are considering proposals to privatise some or all services, and list by hospital:
  - (a) which services are anticipated to be delivered by the private sector at that hospital;
  - (b) at what stage are negotiations at for each hospital with proposed privatisation of services; and

- (4) How many patients from each of the above regional hospitals were transferred and/or referred to general or regional hospitals in Perth in 2011?
- (5) For what clinical services were these patients transferred and/or referred (please provide information broken down by number of patients per clinical service)?

7885. Mr R.H. Cook to the Minister for Health

I refer to the free ambulance cover for all aged pensioners which was introduced by the State Government in 2005, and ask:

- (a) what is the current cost to the State Government of providing free ambulance cover to all aged pensioners in Western Australia;
- (b) how many aged pensioners in Western Australia currently have access to free cover under this scheme;

- (c) please provide details on how funding for the scheme operates, in particular:
  - (i) does the Government pay for ambulance-only cover for all aged pensioners directly to organisations such as HBF or St John's Country Ambulance Cover; or
  - (ii) does the Government retrospectively pick up the cost of invoices for actual ambulance services used?
- (d) does the Government intend to continue this scheme and, if so, what is the projected cost of the scheme over the next four years;
- (e) are self-funded retirees over 65 who are not aged pensioners still eligible for subsidised ambulance cover (50 per cent) and, if so, how does this work, in particular:
  - (i) is the Government paying for 50 per cent of the insurance costs of ambulance-only cover for self-funded retirees; or
  - (ii) does it pay 50 per cent of the invoiced bills for ambulance services used by self-funded retirees; and
- (f) are all non-urgent medical attendances by ambulances to aged pensioners billed at the full rate?

7886. Mr J.N. Hyde to the Minister for Heritage

- (1) What are the Government's intentions for the State-heritage listed former prison warders' cottages at 7-41 Henderson Street, Fremantle?
- (2) How long have the cottages been emptied and fenced off?
- (3) Which Government department now owns the cottages?
- (4) Will the Minister recommend use of section 112 of the new *Building Act 2011*, which came into effect in April 2012, to ensure the relevant department undertakes repairs and upkeep?
- (5) What is the value of the cottages in any Government assets register?
- (6) What plans have been endorsed to restore the cottages before they succumb to demolition by neglect?
- (7) What costing has been undertaken to restore the buildings?

7887. Mr J.N. Hyde to the Minister for Planning

The Minister's 21 April 2012 media release states that, in addition to the release of the draft design guidelines, a proposed scheme amendment officially transferring planning authority for the Perth Waterfront project to the Metropolitan Redevelopment Authority (MRA) was open for public consultation. In relation to this, I ask:

- (a) why is this further amendment needed after Parliament has already debated the MRA Bill and a scheme amendment relating to the Perth Esplanade;
- (b) when will the scheme amendment be presented to Parliament;
- (c) what is the final date for a disallowance motion to be moved on this amendment in both houses of Parliament; and
- (d) as public comment on this scheme amendment does not close until 5 June 2012, what effect has this had on delivery timelines for the Waterfront Project?
