- (e) whether the officer is issued with a mobile phone;
- (f) whether the officer is issued with a credit card;
- (g) if issued with a credit card, the credit card limit;
- (h) whether the officer is issued with a vehicle;
- (i) whether the officer is issued with a laptop, home computer and/or fax;
- (j) whether the officer has permission for a second job; and
- (k) where permission is granted for a second job, what that second job is?

Regarding the use of databases in the Western Australian Police, I ask -

- (1) What databases do the Western Australian Police hold that contain identifying particulars of people?
