70. Regulation of Lobbyists

Hon Giz Watson: To move -

That a Joint Select Committee be appointed to -

- (1) Inquire into and report on regulation of lobbyists in Western Australia, and in particular to -
 - (a) review the State Government's Contact with Lobbyists Code and Register of Lobbyists;
 - (b) consider the application of a lobbyists code and register to apply to contact between lobbyists and all Members of Parliament; and
 - (c) consider whether legislation is required to further regulate the activities of lobbyists in Western Australia.
- (2) Inquire into and report on the appropriateness of the powers and penalties provided for in the *Parliamentary Privileges Act 1981* and *The Criminal Code* in respect to breaches of parliamentary privilege and contempts of parliament and requests the Legislative Assembly to agree to a similar resolution.

Select Committee into Placement of Aboriginal and non-Aboriginal children

Hon Robyn McSweeney: To move -

1. That a select committee of three members be appointed, any two of whom make a quorum.
2. The committee and proceedings of the committee are subject to chapter XX11 of Standing Orders and is to be regarded for all purposes as a committee appointed under that chapter.
3. The committee is to inquire and into and report on -
 - a. The reasons as to why 152 Aboriginal children under the age of six have had multiple placements.
 - b. The reasons as to why 142 non-Aboriginal children under the age of six have had multiple placements.
 - c. A review of the recommendations put forward by the Select Committee into "The Adequacy of Foster Care Assessment procedures by the Department of Community Development", which reported in August of 2006.
 - d. To review the Department of Child Protection policies and procedures on placing Aboriginal and non-Aboriginal children into care.
 - e. Any other related matter that the committee considers relevant.
4. The Committee is to report no later than 23 October 2008.
