9. Dog Amendment (Stop Puppy Farming) Bill 2021

- to amend the *Dog Act 1976* to provide for matters relating to the sterilisation and breeding of dogs and the supply of dogs to and by relevant pet shop businesses; and
- to amend the *Dog Act 1976* and the *Cat Act 2011* to provide for a centralised registration system; and
- to make other amendments to the *Dog Act 1976* and the *Cat Act 2011*." be introduced and read a first time.

Question put and passed.

The Minister for Local Government moved, That the bill be now read a second time.

Mr P.J. Rundle moved, That the debate be adjourned.
