I refer to transfers from Joondalup Health Campus (JHC) to tertiary hospitals, and ask:

(a) how many patients have been transferred from JHC to tertiary hospitals in 2012 to date;

- (b) what is the average transfer journey time (travelling by ambulance) from JHC to each of these hospitals:
  - (i) Sir Charles Gardiner Hospital
  - (ii) Royal Perth Hospital
  - (iii) King Edward Memorial Hospital
  - (iv) Princess Margaret Hospital
- (c) what is the longest amount of time a single patient transfer from JHC to a tertiary hospital has taken?
- (d) have any patients died during patient in-transit from JHC to a tertiary hospital since 2008 and, if so, how many?

### 8006. Mr J.N. Hyde to the Treasurer

Regarding tenders or contracts by Treasury, agencies or Government to ratings agencies, I ask:

- (a) what tenders or contracts are currently in place, with what terms and remuneration;
- (b) what amount was provided to ratings agencies in each financial year of the Barnett Government and what is budgeted for 2012–2013 and forward estimates;
- (c) what due diligence was undertaken by this Government into anti-corruption processes and safeguards of ratings agencies engaged; and
- (d) what are the current anti-corruption processes and safeguards of ratings agencies engaged?

### 8007. Mr M.J. Cowper to the Minister for Environment

Given that liquor burners have been banned across the world, can the Minister please advise:

- (a) what independent environmental monitoring is being conducted on the following liquor burners in Western Australia:
  - (i) Kwinana Refinery;
  - (ii) Wagerup Refinery; and
  - (iii) Worsley Alumina Refinery;
- (b) what makes these liquor burners more efficient and subsequently safe, compared to those banned in the United States, Asia and Europe;
- (c) what questions did the Minister ask the Ministers for Health, State Development and Mines and Petroleum prior to approving a time extension of the expansion at Wagerup Refinery;
- (d) in increasing the allowable level of noise emissions from the Wagerup refinery, how many noise affected properties will Alcoa need to purchase to satisfy the requirement of the license; and
- (e) what will happen if no additional properties are purchased by Alcoa?

### 8008. Mr R.H. Cook to the Minister for Health

I refer to the free dental screening service pilot program for 0-4 year olds currently underway and undertaken by the Department of Health in Swan View, and ask:

- (a) is Swan View the only location where the pilot is being undertaken;
- (b) what is the cost of the pilot program;
- (c) how many full-time equivalent (FTE) staff are employed in the pilot program;
- (d) how many children have been screened to date as part of the pilot;
- (e) what is the average cost per screening to the Department of Health;

- (f) how many children does the Department anticipate screening by the completion of the program;
- (g) what are the preliminary findings of the pilot;
- (h) is the pilot going to be formally evaluated upon completion and, if so, will the Minister provide a copy to the evaluation report;
- (i) has the Department previously undertaken any feasibility studies on providing a free dental screening service for 0-4 year olds; and
- (j) what (if any) free dental services are available for 0-4 year olds in the public health system, apart from the emergency dental services at Princess Margaret Hospital?

#### 8009. Mr R.H. Cook to the Minister for Health

I refer to Dental Care Assistants (DCAs) in the public dental system (including school clinics), and ask:

- (a) how many full-time equivalent (FTE) DCAs are currently employed in the State's public dental system;
- (b) how many total FTE DCA positions (both filled and unfilled positions) are there in regional and remote areas of the State's public dental system;
- (c) how many current vacancies are there for FTE DCAs in the State's public dental system in regional and remote areas;
- (d) how many DCA's currently receive Government Regional Officer Housing;
- (e) in which locations are DCA's presently receiving Government Regional Officer Housing;
- (f) why are some DCA's in regional and remote areas receiving housing while others are not;
- (g) how much, on average, does it cost the Department of Health, per annum, per employee for Government Regional Officer Housing (that is, how much is the average out-of-pocket cost to the Department once the employee has paid their subsidised rent);
- (h) how many DCAs in the State's public dental system currently have Certificate 4 qualifications or higher;
- (i) what is the average ratio of DCA to dental operator (DCA to dental therapist or dental officer) in the State's public dental health system;
- (j) which public dental service currently has the worst ratio of DCA to dental therapists and/or officers, and what is that ratio; and
- (k) how many additional DCAs would need to be recruited to provide a 1:1 ratio in the State's public dental health system?

### 8010. Mr R.H. Cook to the Minister for Health

I refer to staff shortages in the public dental system (including school clinics), and ask:

- (a) how many full-time equivalent vacancies are there presently in the State's public dental system;
- (b) have any public dental services closed since September 2008 and, if so, which services have permanently closed and where are they located;
- (c) have any public dental services reduced their opening hours since September 2008; and
  - (i) if so, which services;
  - (ii) if so, where are they located; and

- (iii) if so, what are their revised operating hours; and
- (d) have any public dental services undergone temporary closures since September 2008 due to staff shortages; and
  - (i) if so, which services; and
  - (ii) if so, where are they located?

### 8011. Mr E.S. Ripper to the Minister for Forestry

- (1) Will the Minister table the specifications for the grading of jarrah saw logs as being first, second or third grade saw logs or bole logs?
- (2) Does the Minister plan to revise the specifications for grading of jarrah saw logs so that there is no confusion over the grading of logs supplied to mills?

- (3) How many Consultation Regulatory Impact Statements were considered by Treasury:

- (4) How many Decision Regulatory Impact Statements were considered by Treasury:

- (8) Has Treasury undertaken any tracking or evaluation of the average time it takes for agencies to complete the RIA process, from the time a PIA has been submitted to the approval of the proposed regulatory change?

- (9) What key performance indicators are used to determine the efficiency and effectiveness of the process?
- (10) How many Regulatory Gatekeeping Unit Annual Reports have been published to date?
- (11) What were the terms of reference for the Regulatory Impact Assessment 2011 Review?
- (12) Has the review noted at (11) been reported to the Treasurer and, if so, when?
- (13) When will the review noted at (11) be made public?

#### 8013. Mr R.H. Cook to the Minister for Health

I refer to St John of God, the State Government's preferred respondent to operate the new Midland Health Campus. Comments made by a Catholic Health Spokesperson on 25 February 2012 suggest that there will be some procedures which St John of God will not be able to provide, and a North Metropolitan Area Health Spokesperson, in *The West Australian* on 14 April 2012, suggested that if a contract is reached with St John of God it was expected that services such as pregnancy termination, sterilisation and contraception would not be provided. In relation to this, I ask:

- (a) is the Minister concerned that St John of God may impose its beliefs on public patients, effectively restricting some of the clinical services available at the Midland Health Campus;
- (b) given that a St John of God doctor was recently sacked from St John of God, Subiaco, for performing a vasectomy on a patient, and also that vasectomies are currently available to public patients at Swan District Hospital, will this clinical service be provided at the new Midland Health Campus;
- (c) will St John of God's staff abide by the wishes of patients at Midland Health Campus who have advanced health care directives (Living Wills);
- (d) will St John of God refer pregnant patients with abnormal defects, or a high risk of genetic conditions in their unborn foetus, to genetic counselling services at King Edward Hospital; and
- (e) will pregnant patients, whose scans and or blood tests reveal a high risk of foetal abnormality, be referred to a place where they can secure a free termination under the public system?

### 8014. Mr J.N. Hyde to the Premier

I refer to the Premier's comments in the Legislative Assembly on 28 February 2008, in which he stated that the issue of the rock art on the Burrup Peninsula is probably the most significant heritage issue that Western Australia has ever faced. He further stated that, as it was a difficult issue, the Parliament did not deal with it, the Government did not deal with it and that it was left to Canberra to resolve. In relation to this, I ask what specific steps the Premier has taken to address what he terms the most significant heritage issue that Western Australia has ever faced?
