1. Meeting of Assembly

The Assembly met at 9.00 am pursuant to adjournment.

The Deputy Speaker took the Chair.

Prayers were read.

2. Papers

The Minister for the Environment on the release by the Cockburn Sound Management Council of its 2006-2007 annual environmental report cards.

The Minister for Energy on the promotion of the "Reach for the Stars" energy label awareness program by the Sustainable Energy Development Office and its use in the latest Harvey Norman advertising catalogue.

The Minister for Small Business on her official visit to Auckland, New Zealand from 31 August to 2 September 2007 to launch the third phase of the "Go West Now" skilled migrant attraction campaign.

Under Standing Order 80, Dr J.M. Woollard asked why no answer had been received in respect of her Question on Notice No. 2483.

11. Message from the Legislative Council

Message No. 170 dated 19 September 2007 from the Legislative Council was reported as follows -

The Legislative Council requests the Legislative Assembly grant leave to Mr Trevor Sprigg MLA, to give evidence before the Standing Committee on Estimates and Financial Operations appointed to inquire into the Memorandum of Understanding between Balga Senior High School and Manufacturing Industry Training Services Pty Ltd, if he thinks fit.

Deputy Speaker's Statement - Legislative Assembly Members giving evidence to Legislative Council Committees

The Deputy Speaker advised members that -

A Legislative Council Committee may not seek to take evidence from members of this House unless the Council sends a message to the Assembly requesting that they appear before the relevant committee. A message is not required however if a member of the Assembly has initiated the approach to a Council committee and asked to give evidence, nor is an Assembly member precluded from sending a written submission to a Council Committee in response to an invitation issued in the broad to all members and perhaps others. If however the Council Committee initiates an approach to an Assembly member specifically, the formal requirement must be followed.

The same situation applies in respect of a Council member giving evidence to an Assembly committee. In relation to Joint Committees, members of either House may be invited to given evidence before those committees without any communication between the Houses.

Legislative Assembly Standing Order 305 encapsulates the procedures as follows:

305. If the Assembly or a committee wishes to examine a member or officer of the Council, a message will be sent requesting the Council to grant leave for the member or officer to be examined on the matters stated in the message.

In this case, where the member for Murdoch has volunteered his attendance before a Council Committee, specifically seeking to attend, there is no technical need for the Council to seek leave from the Assembly. As the courtesy request has been extended to the Assembly in this case, a reply in accordance with Standing Order 306, specifying that the member may attend if he thinks fit, should be considered by the House.

Ordered by leave, That consideration of Legislative Council message No. 170 be undertaken forthwith

The Leader of the House, pursuant to the foregoing motion, moved,

- That this House gives leave to the Member for Murdoch to attend before the Legislative Council Standing Committee on Estimates and Financial Operations in relation to its inquiry into the Memorandum of Understanding between Balga Senior High School and Manufacturing Industry Training Services Pty Ltd.
- (2) That the Legislative Council be acquainted accordingly.

Debate ensued.

Question put and passed.

12. Fiona Stanley Hospital Construction Account Bill 2007

Clause 4, page 2, line 20 — To insert after "hospital" —

" including purchase of relevant land".
