1534. Hon Ben Dawkins to the Parliamentary Secretary to the Minister for Water:

I refer the Minister to page 12 of the Water Corporation's Mdour Modelling Study contained in the Water Corporation's Amendment Report dated 31 March 2010 relating to the *Greater Bunbury Region Scheme Amendment* and the reduction of its wastewater treatment plant odour buffer which states under section 9 in the eighth bullet point, "there is not a strong argument to change the boundary of the buffer zone"; and "applying the precautionary principle is warranted because there is always a degree of uncertainty about the predictions of odour modelling for plants that are still to be designed, constructed and operated", and I ask:

- (a) given the above statements, why did the Water Corporation agree to the amendment to the *Greater Bunbury Region Scheme* to reduce the odour buffer;
- (b) why did the Water Corporation agree to further reduce the odour buffer from what is shown in Figure 18 of the Study (Further Reduction); and
- (c) did the Department of Housing or any other government agency ask or represent to the Water Corporation to consider reducing its odour buffer or agree to the Further Reduction?
