MOTIONS

68. Education - Behaviour Management and Pastoral Care *(Notice given 4 December 2007)*

Continuation of introductory remarks Hon Peter Collier (Wednesday, 18 June 2008) in moving the following motion -

That this House expresses its concern at the lack of comprehensive and effective behaviour management and pastoral care strategies in Western Australian public schools.

69. Commodity Timber Products *(Notice given 5 December 2007)*

Hon Paul Llewellyn: To move -

That in light of the Forest Product Commission's poor financial performance in the native forest sector; the failure of regulation and compliance of native forest logging; the impact of logging on the habitat of vulnerable species; the compelling evidence of native forest ecosystems at risk of irreparable damage; and the compounding impact of climate change, this House calls on the Government to -

- (1) Set in place a full transition to plantation and farm forestry for the production of commodity timber products currently derived from native forests.

- (2) Develop an exit strategy for the native forest commodity timber industry in the course of the mid term review of the Forest Management Plan, to be implemented in the term of the current Forest Management Plan ending in 2013.
- (3) Put in place an independently refereed, scientifically based program to restore the ecological integrity of native forests which underpins the delivery of clean air, clean water, carbon sequestration, biodiversity and natural heritage values of the South West region.

71. Establishment of Indigenous Housing Fund (*Notice given 19 February 2008*)

Hon Shelley Archer: To move -

That this House -

- (1) Accepts and underlines the pre-eminence of the Inquiry into the *Response by Government Agencies to Complaints of Family Violence and Child Abuse in Aboriginal Communities* (the Gordon Inquiry) and the need for an effective and speedy response from Government.
- (2) Acknowledges the importance of the finding by the Gordon Inquiry that the provision of adequate housing is a key factor in reducing pressure on families and hence reducing family violence and child abuse.
- (3) Recognises that, to date, well intentioned policies implemented by successive Governments to provide decent housing in indigenous communities have failed and a new approach is required.
- (4) Stresses the urgency of the needs of Aboriginal Communities.
- (5) Urges the Government to establish an Indigenous Housing Fund, to be administered by a board of trustees for the benefit of indigenous communities, with the trustees to be appointed on the basis of their business, community and policy skills and expertise and their standing in the community.
- (6) Requests the Government -
 - (a) allocate a minimum of \$150 million dollars to support the Indigenous Housing Fund in the first 3 years of its operation; and
 - (b) establish clear and meaningful outcomes to be met by the trustees in the administration of the fund, but otherwise allow innovation and freedom from bureaucratic restrictions in the achievement of those outcomes.

Hon Ray Halligan: To move -

That this House demands the Government immediately -

- (1) Reveal the current position of the Office of Shared Services in relation to its stated objectives to -
 - (a) reduce costs;

- (2) Justify the massive over expenditure of taxpayer's money on this project.
- (3) Explain how the Government, through incompetence and/or mismanagement, has again squandered taxpayer's resources.

- (g) Law and Order; and
- (h) Employment.

 - (B) iron ore royalties and other revenues received by the State (in relation to both quantum and time of receipt);
 - (ii) whether the iron ore policy is anti-competitive in the current market in that it prevents the turn-over of ground and thereby -
 - (A) preserves the market power of existing members of the iron ore industry; and
 - (B) operates as a barrier to entry to new entrants into the market;

- (f) whether the original rationale for the iron ore policy remains applicable today;
 - (g) whether there is still any need to treat iron ore differently to other mineral commodities under the *Mining Act 1978 (WA)*; and
 - (h) whether it is still necessary and appropriate to use government agreements to facilitate the development of iron ore resources or whether the *Mining Act 1978 (WA)* provides an adequate and appropriate vehicle.
