The President presented the Nineteenth Report of the Standing Committee on Procedure and Privileges in relation to the Petition for Relief - Noel Crichton-Browne (Tabled paper No. 400)

Statement by President

The President made the following Statement -

Members.

I present for tabling the Nineteenth Report of the Procedure and Privileges Committee, into a petition for relief.

This inquiry has been the first undertaken by the Procedure and Privileges Committee since the adoption of the amendments to Standing Order 134 by the House in 2000. While this report deals primarily with the specific allegations raised by the petitioner, the Committee has noted in the report the potential for matters arising under the Standing Order to have a "stifling effect" on debate in this House.

I advise members I will request the Procedure and Privileges Committee to undertake a review of the operation of Standing Order 134, in particular having regard to whether a form of threshold or a test should apply to future petitions to ensure that prayers for relief have adequate substance and raise matters of sufficient importance to warrant a hearing. The Committee may also consider the role of solicitors in verifying the facts in the affidavit accompanying such petitions.

7. Not-For-Profit Sector - Government Support

Hon Sue Ellery: To move on the next day of sitting -

That this House notes the changing demands for assistance on the Western Australian not-forprofit sector and calls on the Barnett Government to ensure the sector has appropriate resources and capacity to meet demand.

That this House notes the Recommendations of the *Group Analysis of Aboriginal Child Death Review Cases in which Chronic Neglect is Present* report of the Child Death Review Committee and calls on the Minister for Child Protection to provide quarterly reports to the House on the implementation of those recommendations.

9. Parliamentary Superannuation Board - Appointment of Members

The Leader of the House moved, without notice -

That Hon Bruce Donaldson and Hon Kate Doust be appointed as Members to the Parliamentary Superannuation Board.

10. Select Committee into Public Sector Expenditure - Establishment

Motion No. 2 having been called, debate resumed on the motion, as amended, of Hon Sue Ellery as follows -

- (1) That a select committee of three members is appointed, any two of whom constitute a quorum.
- (2) The committee and the proceedings of the committee are subject to Chapter XXII of Standing Orders and it is to be regarded for all purposes as a committee appointed under that chapter.
- (3) The committee is to inquire into and report on Government measures to audit the operational and financial performance of the Western Australian public sector, and any other means by which efficiencies in public sector expenditure can be gained and all the circumstances surrounding the implementations of the 3 percent efficiency dividend including -
 - (a) the impacts of the 3 percent efficiency dividend on the general level of service delivery across all agencies; in particular any impacts on service delivery to regional areas;
 - (b) consider alternative methods for achieving a 3 percent reduction in government expenditure;
 - (c) whether the efficiency dividend has a disproportionate impact on smaller agencies, including whether or not smaller agencies are disadvantaged by poorer economies of scale or a relative inability to obtain funding for new policy proposals;
 - (d) what measures agencies are taking to implement the efficiency dividend, and the effect on their functions, performance and staffing arrangements;

- (e) alternatives to an across-the-board efficiency dividend to encourage efficiency in the public sector, including consideration of whether certain agencies or functions of agencies should be exempt from the efficiency dividend, or whether the rate of the dividend should vary according to agency size or function.
- (4) The Committee may present interim reports without a requirement for leave and is to present its final report to the House not later than Tuesday, 12 May 2009.

Hon Ray Halligan moved to amend the motion as follows -

(a)

- (1) To delete paragraph 3(a) and insert instead —
- "
 - (b) the sustainability of the rate of growth in general government expenditure detailed in the 2008-09 Budget;

the impact of the current financial crisis on the State's economy and finances;

- (c) the sustainability of the forecast decrease in operating surplus detailed in the 2008-09 Budget;
- (d) the sustainability of the forecast increase in net debt detailed in the 2008-09 Budget;
- (e) the impacts of the 3 percent efficiency dividend introduced by the former Treasurer, Hon Eric Ripper MLA, and announced in the Pre-Election Financial Projections Statement in August 2008 on the general level of service delivery across all agencies, in particular any impacts on service delivery to regional areas;
- (f) the impact of failing to fully implement the 3 percent efficiency dividend on the operating surplus and net debt;
- (2) In paragraph 3(e) To insert after "function" —

, and if so specific advice on which agencies or functions should contribute a disproportionate share of the \$1,449 million in savings over the forward estimates identified by the former Treasurer, Hon Eric Ripper MLA in August 2008

Debate ensued.

Statement by Deputy President

The Deputy President made the following Statement -

Hon Anthony Fels is apparently seeking a ruling from the Chair on, as I understand it, the date upon which a person elected at a general election to the office of Member of the Legislative Council is to be regarded as a Member-elect and subject to the provisions of the law applying to persons holding an office of profit under the Crown. It is my understanding that that date is the date on which the relevant poll is declared by the relevant returning officer. However, I say to Hon Anthony Fels that it is not a function of the Chair to provide advice on matters of law. It is the function of the Chair to provide, when required, rulings on the interpretation of the Standing Orders and the law, custom and proceedings of the House. It is not a function of the Chair to provide a Member with an interpretation of the laws of Western Australia. This House is bound by the law and the speakers have, to date, raised section 39 of the *Constitution Acts Amendment Act 1899*. The House will make a decision in respect of the motion before us, having regard to the law of this State.

For the benefit of Hon Anthony Fels, I have been advised that in respect of section 37 of the *Constitution Acts Amendment Act 1899*, and in particular to section 37(3), which reads—

If any person to whom this section applies is declared to be elected as a Member of the Legislature, he shall, upon and by virtue of being so declared, vacate the office or place by reason of which this section applies to him.

The point I want to make is that the Clerk has been formally advised of the declaration of the election of, in this case, Ms Mia Davies as a person elected as a Member of the legislature, who is to take her place in this House on 22 May 2009.

By way of formal notice, I inform the Member that the Clerk has advised the Chair that he is in receipt of that document.

Debate resumed.

Question - put and passed.

17. Police (Medical and Other Expenses for Former Officers) Bill 2008

The Order of the Day having been read for the adjourned debate on the second reading of this Bill.

Debate resumed.
