## MOTIONS

---

### 1. **Fishing Industry — Government Compensation** (*Notice given 18 October 2023*)

Hon Colin de Grussa: To move —

That the Legislative Council —

- (a) acknowledges the invaluable economic and social contribution of the fishing industry to our State;
- (b) recognises the impacts of government processes in establishing marine reserves and managing fishing industries with regard to —
  - (i) the potential effects on the future viability of Western Australia's world class commercial and tourism fishing industries; and
  - (ii) the potential impacts on food security and tourism due to the sourcing of fish products from international markets; and
- (c) urges the Government to commit to enhancing statutory and compensatory mechanisms to provide fair and timely compensation to operators affected by Government actions.

### 2. **Armadale Line Shutdown** (*Notice given 14 November 2023*)

Hon Tjorn Sibma: To move —

That this House notes —

- (a) the Minister for Transport's decision to shut down the Armadale line for at least 18 months from 20 November 2023;
- (b) the cost and inconvenience of this decision which further exacerbates the financial costs of the METRONET project;

- (c) the hallmark secrecy which surrounded this decision and the ensuing inadequate consultation with passengers;
- (d) the Minister's failure to provide any compelling evidence that this shutdown is the best solution to facilitate the METRONET program of works; and
- (e) the absence of any plan to mitigate the potential for the shutdown extending beyond 18 months, and the impacts this will have on many commuters across the metropolitan area.

**3. Responsible Exercise of the Corruption and Crime Commission's Powers** (*Notice given 29 November 2023*)

Hon Nick Goiran: To move —

That this House —

- (a) notes with appreciation the Parliamentary Inspector of the Corruption and Crime Commission's report of 27 November 2023 correcting the errors and omissions contained in the Corruption and Crime Commission's (CCC) report of 12 March 2019;
- (b) endorses the Parliamentary Inspector's conclusion that it is not a responsible exercise of the CCC's powers to report to Parliament speculating that a person has 'possibly' committed an offence in a situation where it does not know whether a person has committed a criminal offence, and where it has not conducted sufficient research to determine the matter;
- (c) notes with concern the CCC's refusal to prepare a supplementary report to address the errors and omissions;
- (d) thanks Parliamentary Inspector Matthew Zilko SC for his continued service as a monitor on the operation of the *Corruption, Crime and Misconduct Act 2003*;
- (e) expresses its appreciation to the members and staff responsible for the drafting, tabling and publishing of Report 61 of the *Standing Committee on Procedure and Privileges*;
- (f) notes that the Committee's audit revealed that 1,120 privileged documents were provided without parliamentary approval by the Government to the CCC;
- (g) reasserts that draft parliamentary speeches, motions and questions are subject to parliamentary privilege in the same way as confidential parliamentary committee material such as committee deliberations and draft report recommendations; and
- (h) reminds the CCC that the legislature has entrusted it with extraordinary powers and that its immunity from defamation actions and other claims for damages highlight why those powers must be exercised with caution and prudence.

**4. Bicentennial Anniversary Celebrations** (*Notice given 27 February 2024*)

Hon Tjorn Sibma: To move —

That this House —

- (a) acknowledge the year 2029 will mark the bicentennial anniversary of the foundation of Perth and Fremantle, and the establishment of the Swan River Colony;

- (b) additionally, acknowledge that 2026 will mark the bicentennial anniversary of the establishment of a British presence at Albany;
- (c) that these historic moments set the trajectory for the development of modern Western Australia, subsequently forming part of the Commonwealth of Australia;
- (d) that the commemoration and celebration of these milestones provides an opportunity for all Western Australians, of all backgrounds, both to reflect upon the achievements of our State, and upon our shared aspirations as a unified and cohesive community looking to the next two centuries; and
- (e) that the State Government support a bipartisan approach which funds and coordinates an appropriate program of works and events to mark the bicentenaries in a manner which involves and respects the contributions of all Western Australians.

**5. Elder Abuse** (*Notice given 27 February 2024*)

Hon Nick Goiran: To move —

That this House —

- (a) reminds the WA Labor Government that its January 2017 election manifesto on responding to elder abuse promised that it would “expedite” amendments to the law surrounding enduring powers of attorney and guardianship;
- (b) notes that on 13 September 2017 the Legislative Council established, on the motion of the Opposition, the Select Committee into Elder Abuse;
- (c) reminds the Government that the Select Committee’s 24th recommendation in its 2018 Final Report called on it to “act as a matter of urgency”;
- (d) notes that more than 7 years have passed since the election promise was made;
- (e) expresses its deep concern about the impact on victims of elder abuse given its prevalence in our State; and
- (f) calls on the Government to apologise for breaking trust with the victims, the electors and the Parliament, and to make amends without any further delay.

**6. Home Ownership** (*Notice given 27 February 2024*)

Hon Tjorn Sibma: To move —

That this House —

- (a) commits to the desirability of home ownership as a critical policy objective for any responsible Government;
- (b) that home ownership must remain a plausible and achievable goal for people – so that an individual earning a median income should realistically be capable of purchasing a median-priced dwelling over the long run of economic and property price cycles;
- (c) acknowledge the many forms and sources of policy challenges and impediments to home ownership facing the community of Western Australia; and
- (d) note with alarm that these challenges and impediments to home ownership are disproportionately impacting younger people.

**7. Transport and METRONET** (*Notice given 21 March 2024*)

Hon Klara Andric: To move —

That the Legislative Council commends the Cook Government's investment in transport and METRONET, including the State's first locally built and manufactured C-series train entering service.

**8. Select Committee into METRONET Contracts** (*Notice given 16 April 2024*)

Hon Dr Brian Walker: To move —

- (1) A select committee to be known as the Select Committee into METRONET Contracts is established.
- (2) The Select Committee is to inquire into and report on the issuing and appropriate monitoring of METRONET contracts since the 2017 formation of the METRONET multi-agency team, with particular reference to —
  - (a) due diligence having been undertaken by the Government to ensure that companies in receipt of contracts were legally able to fulfil the terms of those contracts at the time they were granted; and
  - (b) that all such companies have, since the granting of such contracts, operated in compliance with all relevant State and Federal employment laws.
- (3) The Select Committee shall consist of five members, including Hon Dr Brian Walker who is appointed Chair.
- (4) The Select Committee is to report by 28 November 2024.

**9. Fire and Emergency Service Workers and Volunteers** (*Notice given 14 May 2024*)

Hon Martin Aldridge: To move —

That this House —

- (a) notes the impact that trauma has on our frontline fire and emergency service workers and volunteers;
- (b) notes that the State Government has extended PTSD presumptive protections to ambulance and fire and emergency service workers;
- (c) notes that the State Government has committed to acting similarly with respect to Police Officers; and
- (d) calls upon the State Government to ensure that Western Australia's 30,000 fire and emergency service volunteers including ambulance volunteers have comparable protections to those in paid employment, undertaking the same functions.

**10. Science, Technology, Engineering and Mathematics** (*Notice given 30 May 2024*)

Hon Shelley Payne: To move —

That this House commends the Cook Labor Government for its investment in Science, Technology, Engineering and Mathematics (STEM) in our schools, including an increased focus on encouraging more women into STEM related careers.

**11. Construction, Forestry, Mining and Energy Union** (*Notice given 13 August 2024*)

Hon Nick Goiran: To move —

That this House —

- (a) notes with grave concern the revelations of organised crime links within the Construction, Forestry, Mining and Energy Union (CFMEU);
- (b) recognises that when union representatives disregard the law of Western Australia this has an impact on the cost of taxpayer funded projects and the safety of those projects;
- (c) affirms that while law-abiding Western Australians hold a right to freedom of assembly and association, those with a history of serious criminal activity have lost that right and should not be free to consort with one another;
- (d) acknowledges that the *Criminal Law (Unlawful Consorting and Prohibited Insignia) Act 2021* makes consorting unlawful between certain offenders;
- (e) is concerned, however, that due to the stubborn insistence of the WA Labor Government, the *Criminal Law (Unlawful Consorting and Prohibited Insignia) Act 2021* contains a special defence to any charge of unlawful consorting for activities undertaken by members of a registered trade union;
- (f) considers any law allowing a criminal unionist to consort with another criminal unionist to be repugnant; and
- (g) calls on the Cook Labor Government to not fear nor favour the CFMEU or another other union and move immediately to strike this repugnant law from Western Australia's statute book.

**12. Firearms Act 2024** (*Notice given 13 August 2024*)

Hon Nick Goiran: To move —

- (1) That the Standing Committee on Legislation is directed to inquire into and report on the *Firearms Act 2024*, which received Royal Assent on 27 June 2024, including all provisions that have not yet come into operation.
- (2) Without limiting the scope of the Committee's inquiry, the Committee is to:
  - (a) particularly focus its consideration on those provisions of the Act that were passed by the Legislative Council after time for consideration of the Bill in Committee of the Whole had lapsed pursuant to Standing Order 125A;
  - (b) review the operation, effectiveness and implementation of those Parts of the Act that have come into operation at the time that the inquiry is commenced; and
  - (c) report on:
    - (i) whether any provisions of the Act have been implemented in practice by the Government or any agency prior to such provisions having legal force and effect;
    - (ii) whether all provisions of the Act are consistent with Fundamental Legislative Principles;
    - (iii) how the Act may be amended so that every person convicted of a serious offence outside of Western Australia is subject to the same disqualification to hold a firearm licence as those who commit offences in our State; and
    - (iv) any other relevant matter.
- (3) The Committee is to report by 14 November 2024.

**13. Mr Craig Peacock — Letter to the Premier** *(Notice given 14 August 2024)*

Hon Nick Goiran: To move —

That this House —

- (a) notes that the Premier received a letter from Mr Craig Peacock dated 23 January 2024 arising from the Parliamentary Inspector of the Corruption and Crime Commission's report of 27 November 2023 correcting the errors and omissions contained in the Corruption and Crime Commission's report of 12 March 2019;
- (b) further notes:
  - (i) that the Premier evaded the parliamentary questions put to him on 21 March 2024, 16 April 2024 and 7 May 2024 in regard to Mr Peacock's letter;
  - (ii) has, despite repeated requests from Mr Peacock, from a Member of Parliament and from a journalist, not provided any response to Mr Peacock,
- (c) reminds the Premier that it is:
  - (i) reasonable for Mr Peacock to expect an acknowledgement of his letter, together with an indication on what action the Premier is taking and the Premier's timeline for a meaningful and complete response; and
  - (ii) irresponsible at best, and reckless at worst, for the Premier to continue to treat this significant matter with evasion, contempt and constructive silence particularly given the impact this unnecessary approach is having on the mental health of Mr Peacock; and
- (d) urges the Premier to provide a satisfactory response to Mr Peacock, one befitting the office of Premier and one that demonstrates respect for both the seriousness of the Parliamentary Inspector's report and the content of Mr Peacock's letter to the Premier.

**14. Public Service Appeal Board — Adverse findings** *(Notice given 15 August 2024)*

Hon Nick Goiran: To move —

That this House —

- (a) notes the concerning number of significant adverse findings made against Honourable Roger Cook MLA in a decision of the Public Service Appeal Board (PSAB) on 5 January 2023;
- (b) further notes that the PSAB found that:
  - (i) "the Minister did not do everything he could and should have done to ensure leave entitlements were not abused" (adverse finding No. 1);
  - (ii) "it has not escaped our attention that as recently as 2 March 2020 the Minister's Chief of Staff had alerted the Minister to a suspicion that the Kwinana electorate office staff had excessive amounts of leave accrued and may not have consistently applied for leave that was being taken" (adverse finding No. 2);
- (c) also notes that on 21 February 2023, Honourable Roger Cook was asked about adverse finding No. 2 as well as ancillary information about who his

Chief of Staff was on the stipulated date and whether the alert had been delivered in written form;

- (d) is equally concerned by the evasive response to those parliamentary questions regarding adverse finding No. 2 as well as the rudimentary other information sought;
- (e) reminds the Premier that it was WA Labor that undertook to adhere to a "gold-standard of transparency" in government;
- (f) urges the Premier not to place so much weight on the embarrassing evidence delivered by his predecessor when he was sued in the Federal Court that "gold-standard transparency does not apply to every single thing that you do";
- (g) also reminds the Premier of the statement of his colleague Hon Sue Ellery on 17 March 2016 that "secrecy, obfuscation, avoidance and inaccuracy, whether deliberate or not, and dishonesty, are in fact the enemies of our parliamentary democracy"; and
- (h) calls on the Premier to deliver a statement to Parliament confirming that he has ceased his past practice of tearing up leave forms and outlining the steps he has subsequently taken so that there will be no repeat of his conduct that gave rise to the adverse findings made against him by the Public Service Appeal Board.

(Tabled 10 September 2024)

That Recommendations 1 and 2 contained in Report 73 of the Standing Committee on Procedure and Privileges, *E-Petitions*, be agreed to.

Recommendation 1 states —

That the **Temporary Orders** and **Standing Order 101** be repealed, and new Standing Order 101 be inserted as follows —

**101. Form and Contents of Petitions and e-petitions**

- (1) A petition shall —
  - (a) be addressed to the President and Members of the Council;
  - (b) state the action or remedy sought from the Council, which must be repeated at the top of every page of the petition;
  - (c) be legible and unamended;
  - (d) be couched in reasonable language;
  - (e) be in the English language, or be accompanied by a certified English translation;
  - (f) contain the name, address, and original signature or mark of the petitioners;
  - (g) be signed by the person or persons promoting the petition, who must reside in Western Australia or, if a corporation, have its registered office in Western Australia; and
  - (h) if from a corporation, be made under its common seal or, if the corporation does not have a common seal, a copy of the corporation's articles of incorporation must be attached to the petition.
- (2) An e-petition shall —
  - (a) be made in the correct form prescribed by Standing Order 101(1);
  - (b) be facilitated by a Member who shall provide the Clerk with a signed acknowledgement that they are prepared to facilitate the petition;
  - (c) state the nominated period for the petition to be hosted that is to be a minimum of one week and a maximum of six months from the date of publication on the Parliament's website;
  - (d) be joined by persons filling out their correct details and personally agreeing to join the e-petition, and by no one else, except in the case of incapacity from sickness or disability;
  - (e) only be joined by residents of Western Australia.
- (3) A petition shall not —
  - (a) have any documents attached to it;
  - (b) be presented by a Member who has signed the petition as a petitioner;

- (c) reflect upon a vote of the Council in the same calendar year;
  - (d) seek a direct grant of public money from the Council;
  - (e) contain statements adverse to, or make allegations of improper, corrupt or illegal conduct against, a person whether by name or office; or
  - (f) contain or disclose a matter in breach of a secrecy provision of, or order imposed or made under the authority of, a written law.
- (4) An e-petition shall not –
- (a) include or have attached to it any of the exclusions prescribed in Standing Order 101(3);
  - (b) be substantively altered other than by order of the President once published on the Parliament’s website;
  - (c) deal with substantially the same grievance or request substantially the same action as another petition hosted on the Parliament’s website;
  - (d) be signed by a person more than once.
- (5) An e-petition shall be printed by the Clerk in full (including the details of the persons who joined the petition) and prepared for presentation to the Council, by a Member nominated by the principal petitioner, in accordance with Standing Order 102 once the posted period for the e-petition has elapsed.
- (6) In the case of both petitions and e-petitions, the Member presenting the petition shall sign the petition at the top of the front page of the petition.
- (7) The total number of petitioners shall be stated at the top of the front page of the petition.
- (8) The petition must be certified to conform with the Standing Orders by the Clerk before it may be presented to the Council.

Recommendation 2 states —

That the Legislative Council —

- (1) Authorises the Clerk to create and maintain an appropriate website on which to publish e-petitions and other explanatory information.
