THURSDAY, 14 OCTOBER 2010

1. Meeting of Council

The Council assembled at 10.00am pursuant to Temporary Orders.

The President, Hon Barry House, took the Chair and read prayers.

2. Statement by President - Non-Government Members' Drafting Services

The President made the following Statement -

In the course of delivering a Member's Statement on Tuesday, 21 September, Hon. Max Trenorden made reference to his recent dealings with the Parliamentary Counsel's Office (PCO), in relation to assistance being sought by him to draft a Private Member's Bill. Hon. Adele Farina also added some comments.

Members will be aware that, for a number of years, legislative drafting services were provided to Non-Government Members by a private law firm, under contract with the Department of the Premier and Cabinet. This arrangement changed earlier this year, and funding was transferred to the Department of the Attorney General to provide for this service delivery by the PCO.

Legislative drafting is often a complex and time-consuming process. In many instances, the first phase of the drafting process - the development of drafting instructions - can be particularly complicated and protracted. Once these drafting instructions are developed, the second phase of the drafting process begins, and the legislative drafter commences drafting the proposed legislation in accordance with the instructions. These two phases of the process are not exclusive, and often the instructions are refined during the second drafting phase.

In his comments to the House, Hon. Max Trenorden expressed the view that the level of assistance provided by PCO in the first phase of the drafting process, the development of the drafting instructions, did not fulfil his expectations or requirements. I can advise the House that, following those comments from the Member, I have discussed this matter with the Leader of the House and the Acting Clerk. I am also in receipt of advice from the Parliamentary Counsel on this matter and the overall legislative drafting service provision.

In many instances, the development of drafting instructions for Non-Government Bills is and will remain a challenging task. When the Government initiates the drafting of legislation, the resources of Government, including Ministerial and departmental officers, can be applied to the task. The resources available to a Non-Government Member for these purposes are significantly less.

Members have their own electorate staff resources, and the individual Member and their officers will need to undertake a significant part of the work to prepare drafting instructions.

However, contact between a Member or a Member's officers and PCO will be infrequent, and the intermittent nature of this work mitigates against an ongoing working relationship being established between a Member, a Member's office and PCO. With consideration to these factors, I believe the Department of the Legislative Council may fulfil a role in helping to deliver this service.

While a Member still has a responsibility to express their views and proposals for policy and legislative change in a coherent and organised manner, officers of the Legislative Council may be able to assist as a first source of advice and assistance, and to facilitate communication with PCO.

Officers of the Department of the Legislative Council are in regular contact with PCO, and have developed a sound working relationship with PCO officers over an extended period of time. Given this, I believe the Department's officers would be well placed to provide an initial contact, advisory and liaison service between Members, Members' staff and PCO. However, the development of this capacity is dependent upon additional resources being made available to the Department, to deliver this service and a range of other services required by Members which the Department is unable to deliver within its current funding allocation. We are currently in negotiation with Government on our budgetary situation.

I acknowledge to the House that the provision of Non-Government legislative drafting services is critical to the proper discharge of the functions of the Legislative Council, and indicate my intent to pursue the ongoing delivery of this service to Members in a professional and comprehensive manner. I look forward to this service continuing to develop, to enhance the role and effectiveness of the Legislative Council.
