- (b) has there been an occasion where the minutes of a DAP meeting has not been published on the DAP website within ten days of the meeting, and if yes, how many times, and for what reason?

7567. Mr P.C. Tinley to the Minister for Planning

I refer to the payment of Development Assessment Panel (DAP) members, and ask:

- (a) what is the total amount that has, or is expected to be paid to DAP members as sitting or training fees, up to 1 March 2012, and of this amount, what amount has been paid to date;
- (b) what is the total amount that has been claimed by DAP members for travel and other expenses, up to 1 March 2012, and of this amount, what amount has been paid; and
- (c) if payments to DAP members have been delayed, what is the reason for the delay?

7568. Mr P.C. Tinley to the Minister for Planning

I refer to the operation of Development Assessment Panels (DAP), and ask:

- (a) to date, has any decision made by a DAP been taken to the State Administrative Tribunal (SAT) for review, if yes, will the Minister outline which decisions have, or are, the subject of review;
- (b) who represents the DAP in an appeal; and
- (c) what provisions exist in the Act or Regulations that provide for the respondent named in (b) to be remunerated for appearing before the SAT?

I refer to the operation of the Development Assessment Panel (DAP) secretariat, and ask:

- (a) how many staff, measured in Full Time Equivalents, does the secretariat have;
- (b) what has been the total staffing cost of the secretariat to March 1 2012;
- (c) how many staff members, since July 1 2011, have had time off for stress leave; and
- (d) how many hours of stress leave have been taken since July 1 2011?

7570. Mr P.C. Tinley to the Minister for Planning

I refer to the implementation of Directions 2031, and ask, given the implementation of Directions 2031 will rely heavily on the cooperation of Local Governments:

- (a) what funding and assistance have been provided to date to assist Councils to integrate Directions 2031 into their own plans and strategies;
- (b) if no funding has been provided, what was the reason for this lack of support;
- (c) is there any funding planned for this purpose, and if so, how much of this has been included in the Budget forward estimates; and

I refer to Metropolitan Region Scheme Amendment 1216/57, and ask:

- (a) can the Minister explain how this amendment is consistent with Directions 2031 which shows the subject area's zoning as remaining rural;
- (b) is this amendment consistent with the Gnangara Sustainability Strategy, and if so, how:
- (c) is the Minister confident that public consultation on this amendment was adequate given many nearby land owners and residents were not informed directly of this proposal; and
- (d) will the Minister undertake to halt this amendment, and re-open public consultation to allow for proper local community input, and if not, why not?

7574. Mr P.C. Tinley to the Minister for Planning

I refer to the Minister's decision to direct the City of Nedlands to modify its scheme amendment to facilitate developments of greater height and scale along Waratah Avenue Dalkeith, and ask:

- (a) for what reason did the Minister make this direction;
- (b) did the Minister or his office receive any representations from residents, developers or any other party supporting developments of greater height and scale in Waratah Avenue, and if so, from whom; and
- (c) did the Minister discuss this matter with, or have any correspondence with the Member for Bateman regarding this proposal, and if so, on what dates did this communication occur?

7575. Mr W.J. Johnston to the Premier

Is it true that the Premier has not met with any proponents of gas processing projects in the calendar year 2011?

7576. Mr W.J. Johnston to the Premier

- (1) I refer to the Premier's statement in the media in December 2011 that the delay to an investment decision by the Woodside-led Browse project would allow the Inpex-led Ichthys LNG project to use the proposed James Price Point gas processing hub, and I ask:
 - did the Premier have any discussions with Inpex between 19 December 2012 and the 13 January 2012, and if yes, on what date(s), and with whom;
 - (b) on what date did the Premier become aware that Inpex were proceeding with the Ichthys project using on-shore LNG facilities in the Northern Territory;
- I refer to the Premier's estimate that locating Inpex's Ichthys project's on-shore LNG facilities at James Price Point would save the proponent's \$5 billion, and I ask:
 - (a) who calculated the amount of \$5 billion;
 - (b) how was this \$5 billion saving calculated;

- (c) will the Premier table the mathematical model that was used to calculate the \$5 billion saving;
- (d) who developed the mathematical model that was used to calculate the \$5 billion saving; and
- (e) what elements are included in the mathematical model that found this \$5 billion saving?

7577. Mr W.J. Johnston to the Minister representing the Minister for Energy

I refer to Western Power's Mid-West Energy Project, and I ask:

- (a) what is the current estimated cost of Western Power's Mid-West Energy Project; and
- (b) what is the expected completion date of Western Power's Mid-West Energy Project?

7578. Mr J.N. Hyde to the Minister for Planning

In relation to your answer to Question on Notice 7127 indicating the Western Australian Planning Commission owns 299 rental properties in Western Australia, I ask:

- (a) how many properties are located within the City of Perth, City of Vincent and the State electorate of Perth;
- (b) can the Minister identify these properties and their individual value;
- (c) can the Minister please identify the individual rental revenue of each property; and
- (d) how many of the properties in each locality are currently vacant or unlet?

7579. Mr W.J. Johnston to the Minister representing the Minister for Energy

I refer to the Premier's media release of 5 January 2012 headed New Public Utilities Office to be established, and I ask:

- (a) on what day did the Minister for Energy first became aware that the Office of Energy was to cease on 31 March 2012; and
- (b) who informed the Minister for Energy of this decision?

7580. Mr J.C. Kobelke to the Minister for Housing

- (1) Is the Department of Housing seeking to purchase land in Boyce Street, Balcatta for the purpose of building a residential property, and if yes, what is the street address of this property and what is the number and type of dwellings being built?
- (2) Has the Department of Housing contracted for the construct a residential property on land in Boyce Street, Balcatta, and if yes, what is the street address of this property and what is the number and type of dwellings being built?

7581. Mr J.C. Kobelke to the Minister representing the Minister for Energy

- (1) What is the Western Power kit or equipment positioned in Main Street, Balcatta in front of the Balcatta Primary School; and
 - (a) why was it placed at this particular location;
 - (b) when was it placed here;
 - (c) did it require planning or other approvals, and if so from which agencies;
 - (d) what role does it play in the provision of electricity to the surrounding suburbs;
 - (e) is it always in use; and

(f) if it is only operational for certain periods, what are the times and frequency of its operation?

7582. Mr T.G. Stephens to the Premier

- (1) Will the Premier provide full details of any steps that have been taken by any Western Australian government department or agency to advance Hunt Point at Port Hedland for use for industrial infrastructure/tug pen?
- (2) Is the Premier aware that there was government, company and community sign-off on the preferred location of Lumsden Point for this proposed facility?
- (3) Is the State Government aware that the preferred proposed facility at Lumsden Point would position a regional shipping terminal in an area where the Federal Government has previously made an agreement with the State Government to fund and build a major road access route and corridor, and that the planning and development work for this major road link project is now already well advanced?
- (4) Does the State Government consider it reasonable that just seven days were allowed for, over the Christmas and New Year period, as the period for community input and comment and consultation on this proposal for a dramatic change in land use in Port Hedland?
- (5) If no to (4), will the Premier intervene and secure full opportunities for the Hedland community and others with an interest in these local land use issues to engage in effective consultations about the future of both Hunt Point and the previously preferred transport hub that was proposed for Lumsden Point?
- (6) Will the State Government outline to the Hedland community the size and height of any sea wall that will be necessary to protect the safety of proposed infrastructure at Hunt Point and any assessment that has been made about the impact on the amenity of that area for the local community?
- (7) Would the Premier undertake to ensure that the many safety, amenity, environmental, risk management, and infrastructure logistics issues are fully assessed and taken on board by all of the relevant State Government agencies and that due diligence is exercised before this project is further advanced towards approval?

7583. Mr J.C. Kobelke to the Minister for Transport

With respect to the houses on the north side of Reid Highway between Erindale Road and the Mitchell Freeway in Balcatta, I ask:

- (a) what length and height of wall has Main Roads Western Australia built, or contributed to the cost of, in order to ameliorate road noise or block direct vision from Reid Highway, and when was this done and what was the cost;
- (b) have any noise readings been undertaken to assess the levels of road noise impacting on these homes from this section of Reid Highway, and if yes, then when was this done, and will the Minister table a copy of any such noise report;
- (c) are there any plans or preliminary designs to construct a wall or barrier to reduce the noise impact on these homes and provide greater privacy for residents, and if yes, will the Minister table a copy of such plans or designs; and
- (d) what are the anticipated costs of any such works?

- (1) Has the serving of desserts with the patient's meals been abolished at the Armadale-Kelmscott Memorial Hospital, and if yes:

- (2) Is the catering services at the Armadale-Kelmscott Memorial Hospital performed in-house or has it been contracted out, and if contracted out what is the name of the company?
- (3) Have any other public hospitals in Western Australia, removed the provision of desserts to their patients, and if yes how much money will be saved annually?

What changes occurred on the 249, 250 and 251 bus routes during the 2009 calendar year, and when was each route changed, and what was the reason for the changes?

7586. Dr A.D. Buti to the Attorney General

- (1) How many Violent Restraining Orders were issued in Western Australia for the following periods:
 - (a) January to June 2009;
 - (b) July to December 2009;
 - (c) January to June 2010;
 - (d) July to December 2010;
 - (e) January to June 2011; and
 - (f) July to December 2011
- (2) For the same periods mentioned in (1), how many of the Violence Restraining Orders issued were to respondents who had breached a Violence Restraining Order:
 - (a) once;
 - (b) twice;
 - (c) three times;
 - (d) four times;
 - (e) five times; and
 - (f) more than five times?

- 7587. Dr A.D. Buti to the Minister for Regional Development
- (1) Has the Minister made a final decision in relation to the 2011 Regional Development Council's Action Agenda Funding Scheme; and
 - (a) if yes, when did the Minister make his decision;
 - (b) If no, when will the Minister make his decision and what are the reasons for the delay in making his decision;
 - (c) If yes to (1), has the Minister's decision gone to Cabinet for ratification?
 - (d) If no to (c), when will the Minister's decision go to Cabinet for ratification and what are the reasons for the delay?
- When will applicants for the 2011 Regional Development Council's Action Agenda Funding Scheme be notified if they have been successful in being awarded funding under the scheme?
