13. Statement by President - Voluntary Euthanasia Bill 2002 - Release of Bills

Members would be aware that last week the Leader of the Opposition asked whether the *Voluntary Euthanasia Bill 2002* was in order; that is, was the Bill properly before the House given that a copy of the Bill had not been circulated when the motion for the second reading was moved. There is no requirement under Standing Order No. 229 for Bills to be circulated after the first reading. Standing Order No. 229(b) states -

"Copies of the Bill may be distributed to Members and otherwise published after the first reading."

Members may be aware that until the 1980s, Standing Orders required that copies of a Bill not be released until the second reading stage. Having not seen the Bill at the time the question was raised, I have further satisfied myself that the Bill is not out of order by virtue of section 46 of the *Constitution Acts Amendment Act 1899*.
