1. Meeting of Council

President

Reports -

The Council assembled at 3.30pm pursuant to order.

The President, Hon Nick Griffiths, took the Chair and read prayers.

2. Papers

3. Standing Committee on Estimates and Financial Operations - Special Report - Royalty for Regions Policy

Hon Giz Watson presented the Special Report of the Standing Committee on Estimates and Financial Operations in relation to a resolution of the Committee on 1 December 2008 to commence an inquiry into the *Royalty for Regions Policy*. (Tabled paper 388).

Hon Giz Watson moved, That the Report do lie upon the Table.

Question - put and passed.

4. Standing Committee on Uniform Legislation and Statutes Review - Thirty-second Report - Annual Report 2007

Hon Adele Farina presented the Thirty-second Report of the Standing Committee on Uniform Legislation and Statutes Review being the *Annual Report 2007*. (Tabled paper 394).

Hon Adele Farina moved, That the Report do lie upon the Table and be printed.

5. Road Traffic (Charges and Fees) Amendment Regulations (No. 2) 2008 - Disallowance

Hon Ray Halligan: To move on the next day of sitting -

That the Road Traffic (Charges and Fees) Amendment Regulations (No. 2) 2008 published in the Gazette on 30 May 2008 and tabled in the Legislative Council on 5 June 2008 under the Road Traffic Act 1974, be and is hereby disallowed.

Hon Adele Farina moved, That the Report do lie upon the Table and be printed.

Question - put and passed.

The Order of the Day having been read for the adjourned debate on the Address-in-Reply. Debate resumed.

9. **Ouestions Without Notice**

Ouestions without notice were taken.

The Minister for Energy tabled, and by leave incorporated into Hansard, a partial answer in relation to government agencies reporting on their energy usage, in response to a question without notice asked by Hon Kate Doust. (Tabled paper 396).

The Minister for Energy representing the Minister for Heritage tabled, and by leave incorporated into Hansard, documents in relation to advice received regarding the heritage significance of the property known as 'The Cliffe', Peppermint Grove, in response to a question without notice asked by Hon Giz Watson. (Tabled paper 397).

10. Address-In-Reply

Debate resumed on the Address-in-Reply (cf item 8 above).

Point of Order

The Minister for Transport raised the following Point of Order -

I have been accused by the Member of telling lies. I take exception to that language and ask that it be withdrawn.

Acting President's Ruling

The Acting President ruled as follows -

I am not sure that I heard the Member refer to the Minister; I thought I heard him refer to the Government. If my hearing is correct, there is no point of order.

Debate resumed.

Hon Ed Dermer sought leave of the House for Hon Ken Travers to extend his speaking time.

Acting President's Ruling

The Acting President ruled as follows -

Members, Standing Order 73B states from paragraph (ii) that —

- (ii) any Member when speaking in the Address-in-Reply debate or on any motion moved under Standing Order 49(c); or
- (iii) any Bill that the Council may not amend,

and for the purposes of paragraph (i), no time limit shall be imposed, and in the case of paragraph (ii) and (iii) each Member may speak for not more than 60 minutes.

A ruling by the then President, Hon Clive Griffiths, dated 6 November 1996 states that with respect to time limits on speeches on a Bill that this House cannot amend, of which this

happens to be one, nobody, including the Minister or the Leader of the Opposition, gets more than 60 minutes. The ruling states —

In regard to other Bills, a Minister or Member in charge of the business, the Leader of the Opposition, the Leader of the National Party, or any Member speaking on their behalf gets unlimited time, but not two people. If the Leader of the Opposition speaks, he cannot have somebody else speak on his behalf.

Further on it states —

The only person, if it were not a Bill that this House could not amend, who would get unlimited time would be the Leader of the Opposition, or, if he were not to speak, somebody who would speak on his behalf.

The ruling states that Members speaking on the Address-in-Reply are allowed only 60 minutes. The Member's time has expired. We are still dealing with the Address-in-Reply and I call on Hon Ken Baston.

Leave denied.

Debate resumed.

On the motion of Hon Bruce Donaldson the debate was adjourned to the next sitting.
