Dear Mr President

At today's sitting it is my intention to move under SO 72 that the Council consider, as a matter of urgency that the House debate -

(a) the disgraceful waste of taxpayers' money by the Premier and Attorney General in pursuing a hopeless quest for personal vindication of their 1995 loss in the High Court when they cost their colleagues thousands of dollars each in legal costs;

- (b) the cowardly and unconstitutional manner in which the Attorney General is seeking to blame the Solicitor General for the Attorney General's own political decision;
- (c) whether the House should call on the Government to table the opinion of the Solicitor General in order that the people of Western Australia can ascertain the strength of advice upon which the Attorney General acted;
- (d) the failure of the Government to accept the view of the Supreme Court that this area of the Constitution is one that should remain stable;
- (e) the continued determination of the Government to act in an underhand manner;
- (f) the deception it practised on the people of Western Australia when it misrepresented its intentions on voting laws at the last elections; and
- (g) the general lack of integrity of the Gallop Government in its dealings.
