FIRST SESSION OF THE THIRTY-EIGHTH PARLIAMENT

WEDNESDAY, 23 NOVEMBER 2011

1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Speaker's Statement – Media Presence

The Speaker advised members that, in relation to the matter of privilege raised by the Member for Rockingham on 22 November 2011, print media representatives had previously been given approval to take photographs from the public gallery for the first ten minutes in any question time. Access to the proceedings of the Legislative Assembly was subject to an undertaking to comply with a number of conditions. The general rules for the use of visual and audio feeds included a provision that they shall be used only for the purposes of fair and accurate reports of proceedings, and must not be used for, among other things, satire, ridicule or denigration. The Speaker, having looked at the article in question, formed the view that there was not any significant offence against those rules.

3. Petitions

Uranium Mining in Western Australia – Mr C.J. Tallentire presented a petition from 745 persons requesting that the Legislative Assembly recognise the unacceptable risk to the community and the environment posed by uranium mining and to immediately reinstate the ban on uranium mining in Western Australia (P. 507).

No Privatisation of Public Hospitals and Schools – Mr C.J. Tallentire presented a petition from 66 persons requesting that the Legislative Assembly urge the Premier to desist with the Government's privatisation agenda for hospitals and schools (P. 508).

Medical Care in Mt Magnet – Mr V.A. Catania presented a petition from 240 persons requesting that two full time nurses be employed to provide support to each other and to ensure that Mt Magnet has sufficient resources to meet medical care requirements (P. 509).

Medical Care in Cue – Mr V.A. Catania presented a petition from 82 persons requesting that two full time nurses be employed to provide support to each other and to ensure that Cue has sufficient resources to meet medical care requirements (P. 510).

Bus Service for Whitfords Avenue – Ms A.R. Mitchell presented a petition from 53 persons requesting that the Public Transport Authority introduce a return bus service along Whitfords Avenue from Wanneroo Road to Whitfords City Shopping Centre that does not require passengers to change trains at Whitfords Train Station (P. 511).

9. Criminal Organisations Control Bill 2011

The Attorney General, pursuant to notice, moved,

That a bill for "An Act to —

 provide for the making of declarations and control orders for the purpose of disrupting and restricting the activities of organisations involved in serious criminal activity, their members and associates and certain other persons who engage in serious criminal activity, and the imposition of criminal sanctions on persons who recruit members for such organisations or finance or support them in other ways; and

- amend *The Criminal Code* to create certain offences relating to participating in the activities of a criminal organisation, and instructing the commission of offences for the benefit of, at the direction of or in association with a criminal organisation; and
- amend the *Criminal Property Confiscation Act 2000* to enable the confiscation of crime-derived or unlawfully acquired property if a person who is a controlled person or a member of a declared criminal organisation is involved in the commission of an offence; and
- amend the *Evidence Act 1906* to provide special protections to victims and prosecution witnesses in proceedings for certain offences involving criminal organisations; and
- amend the *Misuse of Drugs Act 1981* to enable the making of a drug trafficker declaration if, at the time of the commission of certain drug offences, the offender was a member of a declared criminal organisation; and
- amend the *Sentencing Act 1995* to require the imposition of mandatory minimum sentences on offenders who commit certain offences at the direction of, in association with or for the benefit of a declared criminal organisation, and make such offenders ineligible for parole; and
- make related amendments to various Acts,

and for related purposes." be introduced and read a first time.

Question put and passed.

The Attorney General presented an explanatory memorandum and bill read a first time.

The Attorney General moved, That the bill be now read a second time.

Mr D.A. Templeman moved, That the debate be adjourned.
