1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Shack Site Communities - Petitions requesting that Shack Site communities be preserved so Western Australians have affordable coastal holiday destinations for future generations were presented by –

Ms M.M. Quirk from 155 persons (P. 184); and

Mr B.J. Grylls from 117 persons (P. 185).

Voluntary Euthanasia - Mr M.P. Whitely presented a petition from 98 persons requesting that the Legislative Assembly support measures which would afford terminally ill persons the right to request euthanasia (P. 186).

Urban Development South of Moore River - Mr T.K. Waldron presented a petition from 12 persons requesting that the Legislative Assembly support the recommendation that the land adjoining the proposed Wilbinga Conservation Park be protected from future development (P. 187).

Redress WA - Ms L.L. Baker presented a petition from 378 persons requesting that the decision to reduce the maximum payment available under the Redress WA scheme be reversed (P. 188).
